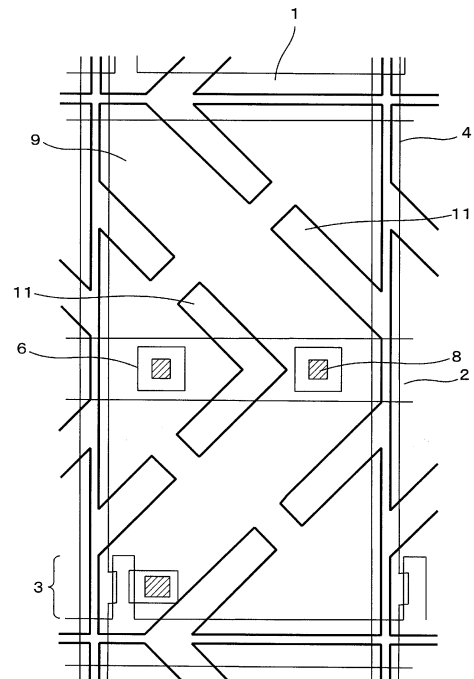

(54) **A substrate for a display device, a method for repairing the same, a method for repairing a display device and a liquid-crystal display device**

(57) The present invention is a substrate for a display device comprising an active matrix substrate and an opposed substrate which are opposed to each other with a display medium layer interposed therebetween, said active matrix substrate including a pixel electrode arranged in a matrix shape on the side of the display medium layer and said opposed substrate including a common electrode opposing to the pixel electrode on the side of the display medium layer, wherein said substrate for a display device includes an electrode slit formed in one of the pixel electrode and the common electrode; and at least one of the electrical connecting portions of said electrode slit is provided outside of a light-blocking region.

摘要(译)

本发明是一种显示装置用基板，包括有源矩阵基板和相对基板，它们彼此相对，介于其间插入显示介质层，所述有源矩阵基板包括在矩阵形状的基板上排列的像素电极。显示介质层和所述相对基板包括与显示介质层一侧的像素电极相对的公共电极，其中所述显示装置用基板包括形成在像素电极和公共电极之一中的电极狭缝；所述电极狭缝的至少一个电连接部分设置在遮光区域的外部。
