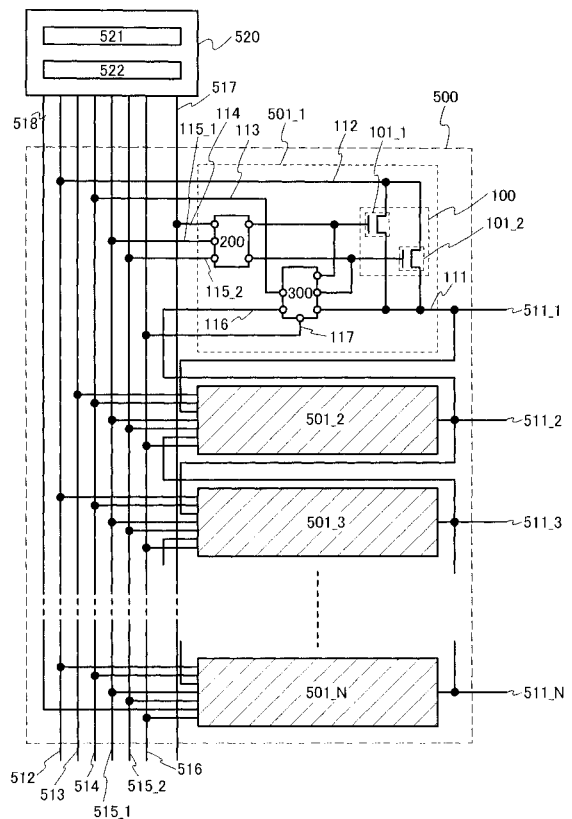

(54) **Liquid crystal display device, driving method of the same, and electronic device including the same**

(57) It is an object to suppress deterioration of characteristics of a transistor in a signal line or a scan driver circuit. A first switch for controlling whether to set a potential state of an output signal by being turned on and off in accordance with the first input signal, and a second switch for controlling whether to set a potential state of an output signal by being turned on and off in accordance with the second input signal are included. A first wiring and a second wiring are brought into electrical continuity by turning on and off of the first switch or the second switch.

摘要(译)

一个目的是抑制信号线或扫描驱动电路中晶体管特性的劣化。第一开关，用于通过根据第一输入信号接通和断开来控制是否设置输出信号的电位状态，以及第二开关，用于通过接通来控制是否设置输出信号的电位状态，以及包括根据第二输入信号的关闭。通过接通和断开第一开关或第二开关，使第一布线和第二布线电连续。
