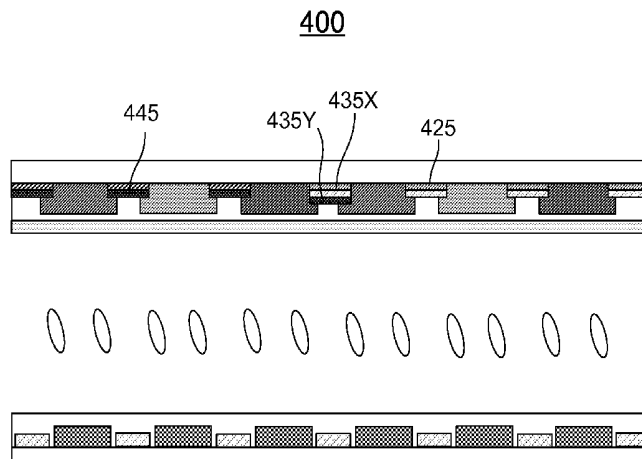
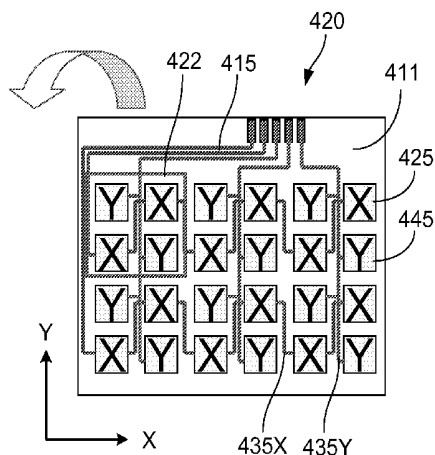

(57) **ABSTRACT**

The present invention relates to a liquid crystal display (LCD). The LCD includes a plurality of display units formed with a first substrate, a color matrix formed on the first substrate, and a common electrode formed on the color matrix, a second substrate spaced from the first substrate, a pixel electrode matrix formed on the second substrate, a liquid crystal material disposed between the common electrode and the pixel electrode matrix. The LCD includes a touch sensing member integrated onto the color matrix of the first substrate.

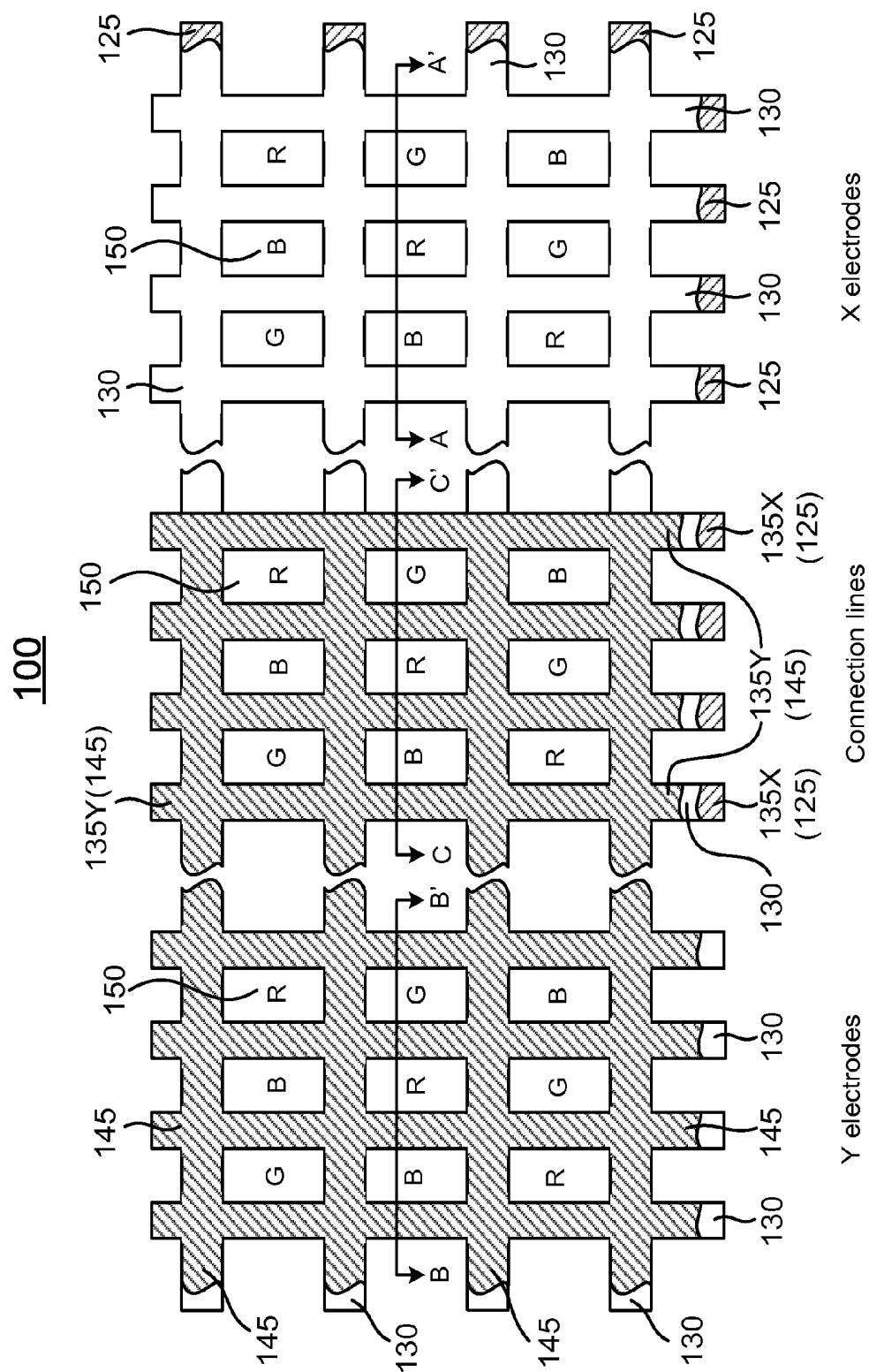

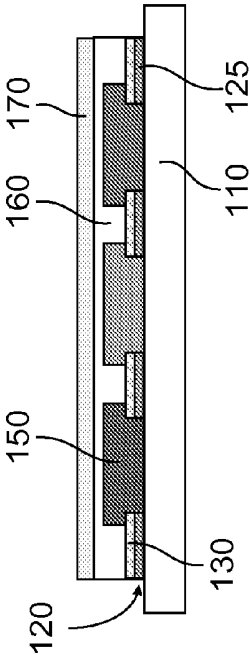

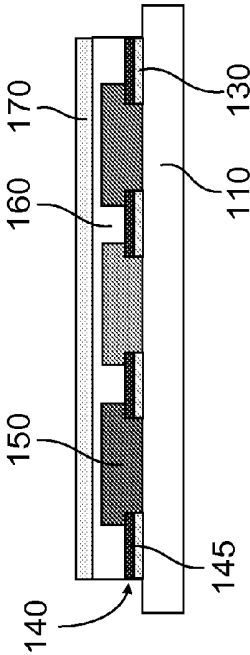

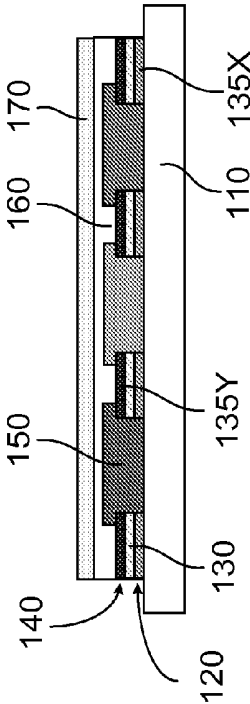

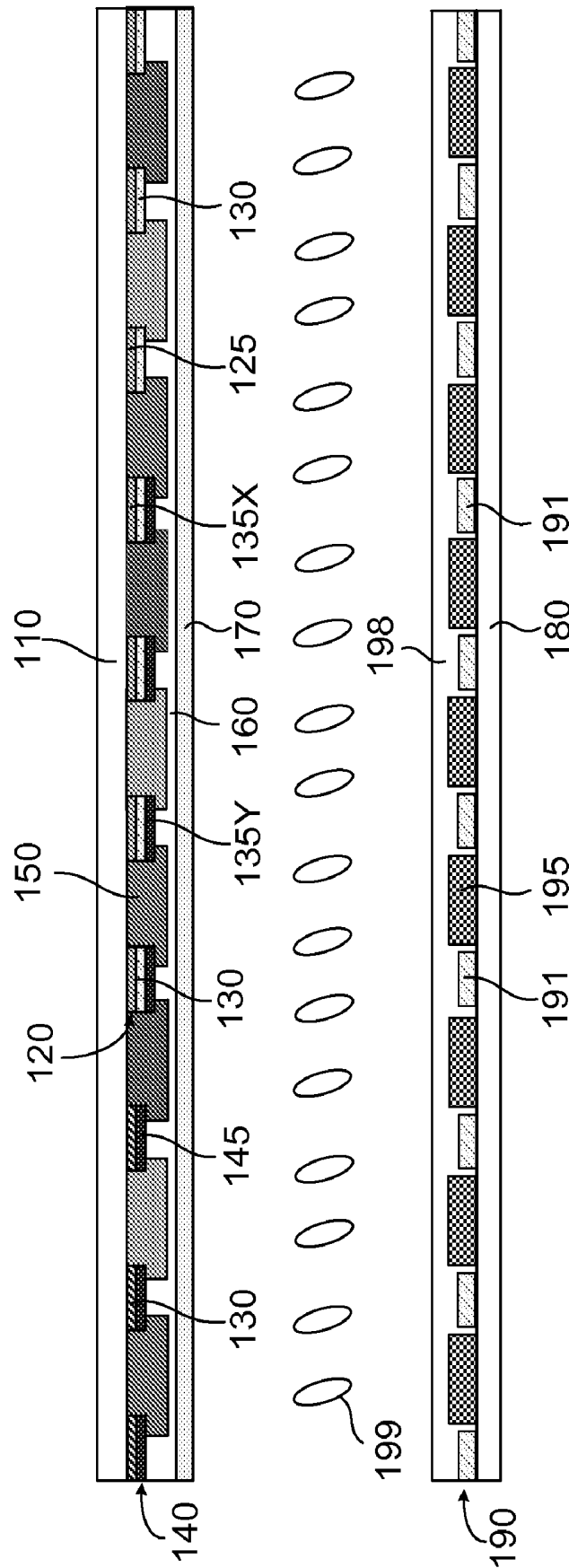

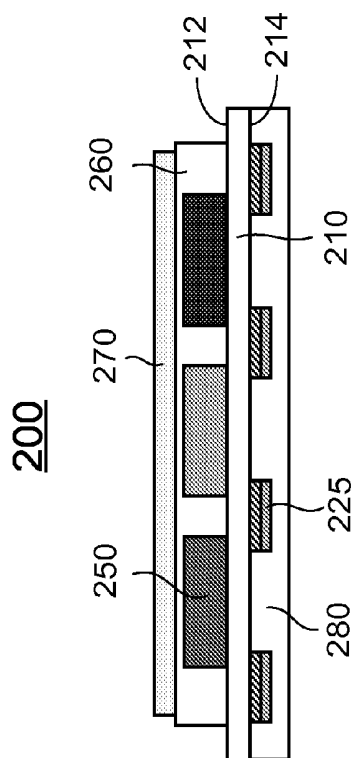

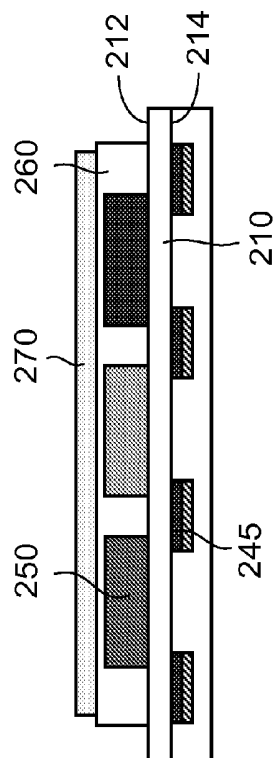

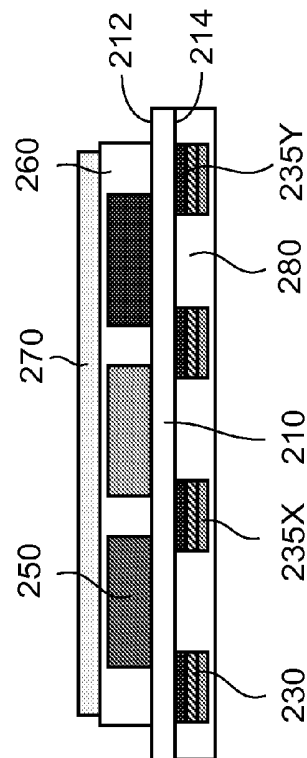

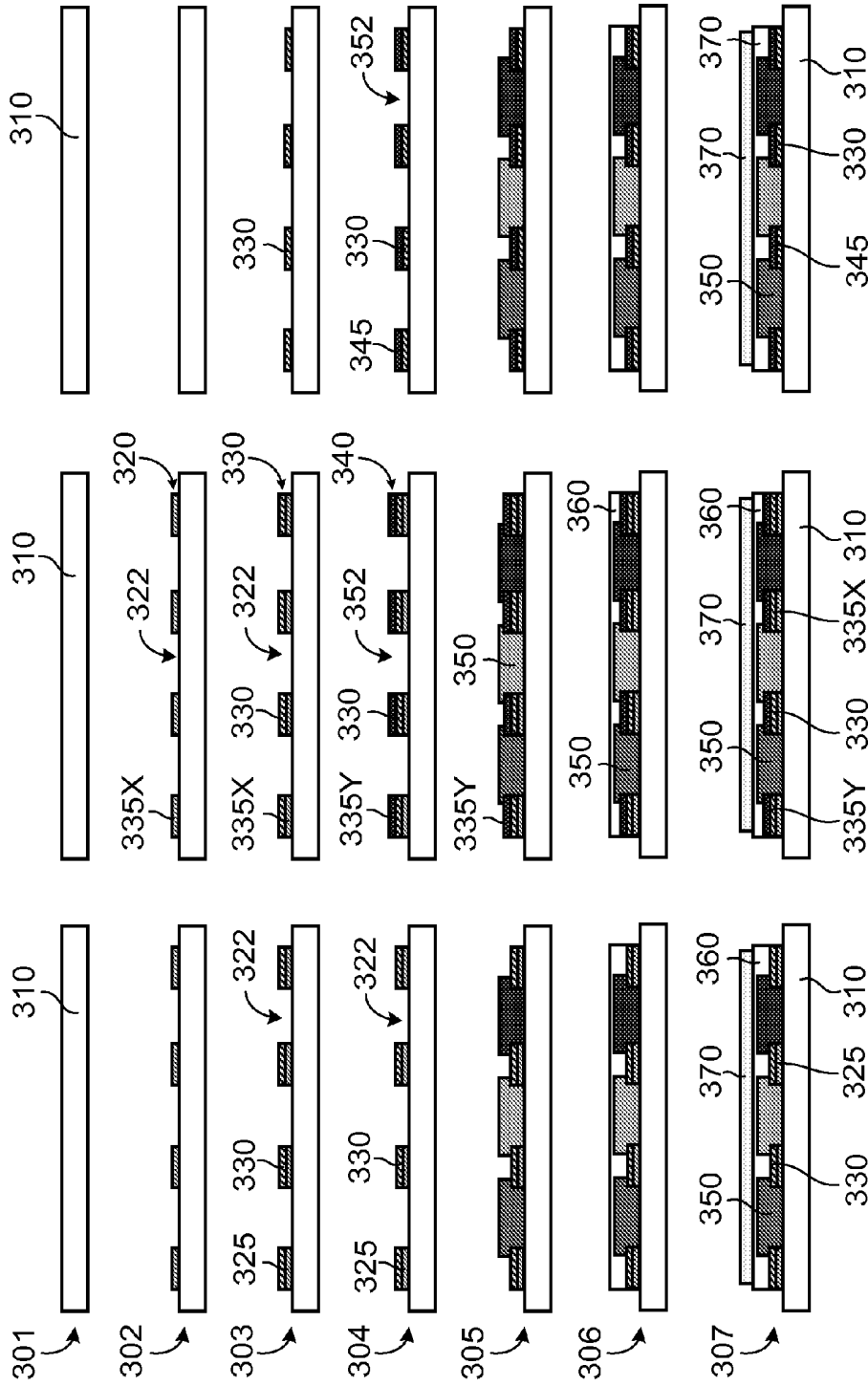

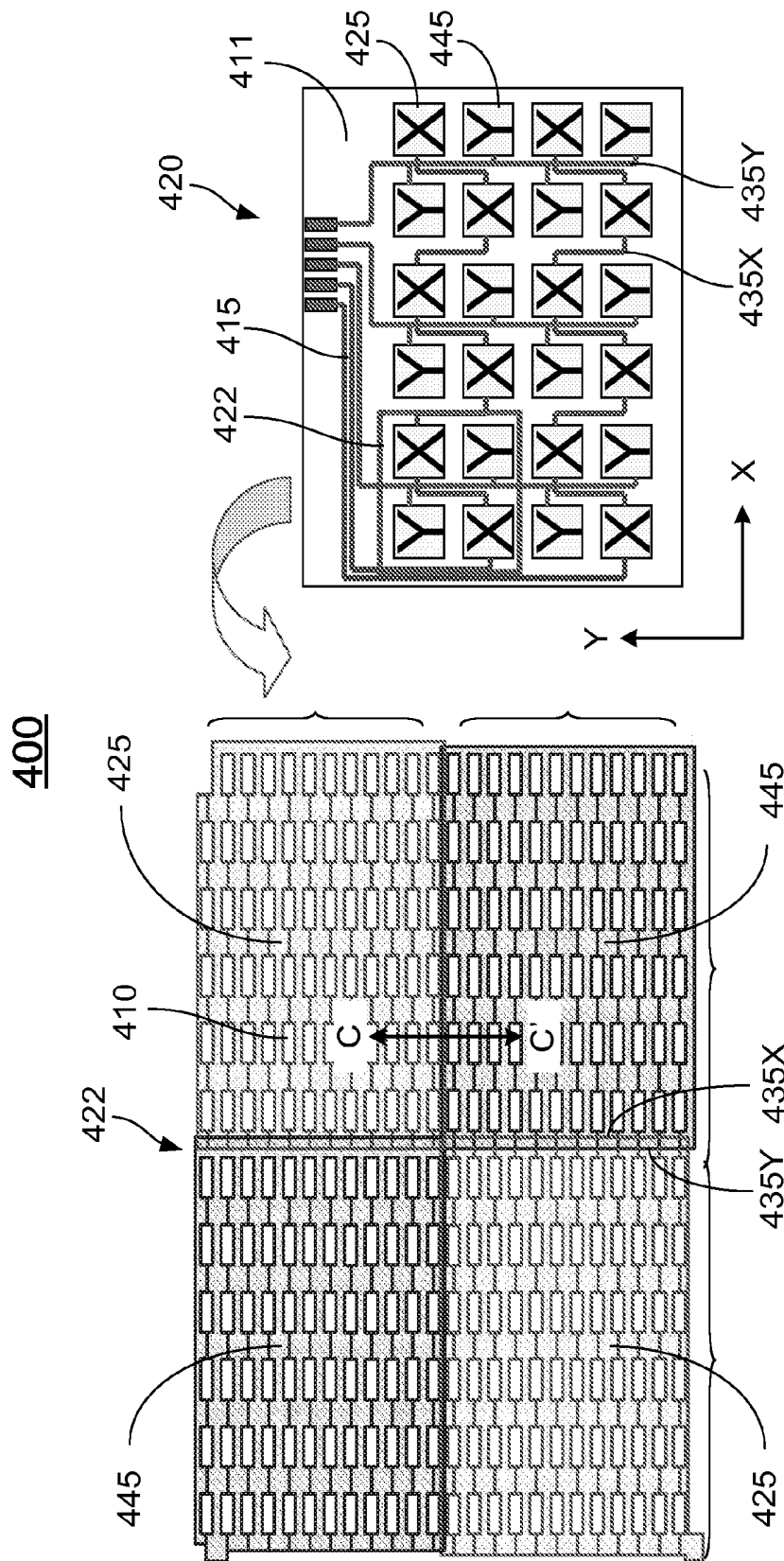

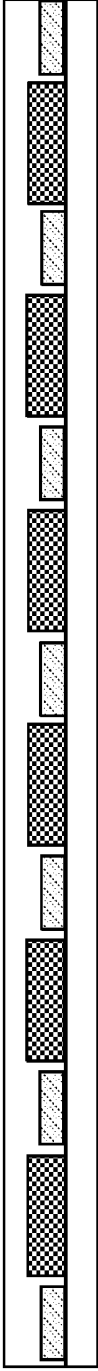
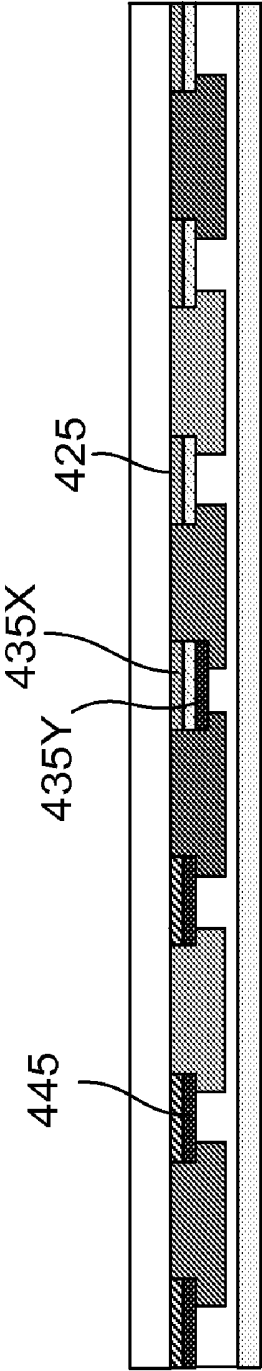

CAPACITANCE TYPE TOUCH PANEL

FIELD OF THE INVENTION

The present invention relates generally to a liquid crystal display (LCD), and more particularly to an LCD having a dual functional touch sensing device integrated with a color matrix of the LCD.

BACKGROUND OF THE INVENTION

Touch sensing technology capable of providing a natural interface between an electronic system and user has found widespread applications in a variety of fields, for example, in mobile phones, personal digital assistants (PDAs), automatic teller machines (ATMs), game machines, medical devices, liquid crystal display (LCD) devices, light emitting diode (LED) devices, plasma display panel (PDP) devices, computing devices, and the like, where a user may input desired information and/or operate the electronic system through a touch sensing device associated with the electronic system. A touch sensing device typically includes a controller, a sensing circuit having a plurality of touch sensors and a network of control lines electrically connecting the plurality of touch sensors to the controller, and a touch panel associated with the plurality of touch sensors.

There are different types of touch sensing devices available for detection of a touch location. One is a resistive-type touch sensing device that includes two layers of transparent conductive material, such as a transparent conductive oxide, separated by a gap. When touched with sufficient force, one of the conductive layers flexes to make contact with the other conductive layer. The location of the contact point is detectable by a controller that senses the change in resistance at the contact point. In response, the controller performs a function, if any, associated with the contact point.

Another one is a capacitive-type touch sensing device. The capacitive-type touch sensing device can be classified into two types: an analog capacitive sensing device, which uses a contiguous resistive layer, and a projected capacitive sensing device, which uses patterned conductive layers (electrodes).

In a projected capacitive touch device, the touch sensor employs a series of patterned electrodes that are driven with a signal from a controller. Similarly, a location of the contact point can be derived from currents flowing through one or more corresponding electrodes toward the touch point responsive to the touch with sensing the capacitance induced by a user's finger. A finger touch to the sensor provides a capacitive couple from the conductive layer to the body. The location of the contact point is detectable by a controller that measures a change in a capacitively coupled electrical signal at the touch location. Accordingly, the controller performs a function, if any, associated with the touch location.

Typically, an integration of a touch sensing device with a display, such as an LCD, is to attach the touch sensing device onto a LCD panel or monitor, which inevitable increases the size and weight of the display.

Therefore, a heretofore unaddressed need exists in the art to address the aforementioned deficiencies and inadequacies.

SUMMARY OF THE INVENTION

The present invention, in one aspect, relates to an LCD. In one embodiment, the LCD includes a first substrate, a first coordinate detecting layer having a plurality of X electrodes parallel and regular-spacingly formed on the first substrate along an X-direction, an insulating layer formed on the first

coordinate detecting electrode layer, a second coordinate detecting layer having a plurality of Y electrodes parallel and regular-spacingly formed on the insulating layer along a Y-direction that is substantially perpendicular to the X-direction, a color filtering matrix having a plurality of red (R), green (G) and blue (B) color pads, each color pad formed on the first substrate in a corresponding space defined by X electrodes or Y electrodes, a transparent overcoat layer formed on the color filtering matrix and uncovered portions of the insulating layer and the plurality of Y electrodes, and a common electrode formed on the transparent overcoat layer. The common electrode is formed of a thin transparent layer of a conductive material. The insulative layer is formed of a transparent, non-conductive material.

The LCD further includes a second substrate arranged to be substantially parallel to the first substrate, a pixel layer having a plurality of pixel electrodes and a plurality of semiconductor devices formed on the second substrate, and a liquid crystal material disposed between the common electrode and the pixel layer. The plurality of semiconductor devices comprises a plurality of thin film transistors (TFTs), each TFT being electrically coupled to a corresponding pixel electrode.

In one embodiment, each of the first substrate and the second substrate is formed of a transparent material. The first substrate and the second substrate are aligned such that each color pad on the first substrate is positioned opposite a corresponding pixel electrode on the second substrate, and the plurality of X electrodes and the plurality of Y electrodes on the first substrate are positioned opposite the plurality of semiconductor devices on the second substrate.

In one embodiment, each of the plurality of X electrodes and the plurality of Y electrodes is formed of a non-transparent, conductive material. The plurality of X electrodes and the plurality of Y electrodes are configured to be a black matrix.

Each of the plurality of X electrodes and the plurality of Y electrodes is associated with coordinates of the first substrate at which the electrode is located. When the first substrate is touched, the touch location at the first substrate is detectable by measuring a signal generated responsively by one or more of the plurality of X electrodes and the plurality of Y electrodes associated with the touch location.

In another aspect, the present invention relates to an LCD, in one embodiment, the LCD includes a first substrate having a first surface and an opposite, second surface, and a color filtering layer formed on the first surface of the first substrate. The color filtering layer is patterned in the form of a color matrix having a plurality of R, G, B color pads aligned along an X-direction and a Y-direction that is substantially perpendicular to the X-direction.

Furthermore, the LCD includes a touching sensing member integrated with the color matrix for detecting a location of a touch point in the first substrate, a transparent overcoat layer formed on the color filtering layer, and a common electrode formed on the transparent overcoat layer.

Moreover, the LCD includes a second substrate spaced from the first substrate, a pixel electrode layer formed on the second substrate, and a liquid crystal material disposed between the common electrode and the pixel electrode layer.

In one embodiment, the touch sensing member includes a plurality of X electrodes parallel and regular-spacingly aligned along the X-direction, and a plurality of Y electrodes parallel and regular-spacingly aligned along the Y-direction. The touch sensing member may further include an insulating layer formed between the plurality of X electrodes and the plurality of Y electrodes.

In one embodiment, the touch sensing member is formed on the first surface of the first substrate such that the plurality

of X electrodes and the plurality of Y electrodes are interleaved with the plurality of R, G, and B color pads of the color matrix. The plurality of X electrodes and the plurality of Y electrodes are formed of a non-transparent, conductive material, whereby the touch sensing member is corresponding to a black matrix.

In another embodiment, the touch sensing member is formed on the second surface of the first substrate such that any two neighboring X electrodes and two neighboring Y electrodes crossover the two neighboring X electrodes define an area on the second surface opposite a corresponding color pad on the second surface of the first substrate. In one embodiment, the plurality of X electrodes and the plurality of Y electrodes are formed of a non-transparent, conductive material, whereby the touch sensing member is corresponding to a black matrix. In another embodiment, the plurality of X electrodes and the plurality of Y electrodes are formed of a transparent, conductive material, and the color matrix further comprises a black matrix interleaved with the plurality of R, G, and B color pads.

In one embodiment, the touch sensing member includes a touch sensor matrix formed on the second surface of the first substrate, the touch sensor matrix having a plurality of sensor units, and the plurality of sensor units being formed of a transparent, conductive material and electrically connected in series aligned along the X-direction and the Y-direction, where each touch sensor unit is associated with at least one display unit. The at least one display unit is defined by a corresponding color pad.

In yet another aspect, the present invention relates to an LCD having a plurality of display units formed with a first substrate, a color matrix formed on the first substrate, and a common electrode formed on the color matrix, a second substrate spaced from the first substrate, a pixel electrode matrix formed on the second substrate, a liquid crystal material disposed between the common electrode and the pixel electrode matrix, where the color matrix includes a plurality of R, G, and B color pads aligned along an X-direction and a Y-direction, and where each color pad is associated with a display unit. In one embodiment, the LCD further comprises a touch sensing member integrated onto the first substrate.

In one embodiment, the touch sensing member comprises a plurality of X electrodes parallel and regular-spacingly aligned along the X-direction, and a plurality of Y electrodes parallel and regular-spacingly aligned along the Y-direction, where the touch sensing member is formed such that the plurality of X electrodes and the plurality of Y electrodes are interleaved with the plurality of R, G, and B color pads of the color matrix.

In another embodiment, the touch sensing member comprises a touch sensor matrix formed on the first substrate, the touch sensor matrix having a plurality of sensor units, and the plurality of sensor units being formed of a transparent, conductive material and electrically connected in series aligned along the X-direction and the Y-direction, where each touch sensor unit is associated with at least one display unit.

These and other aspects of the present invention will become apparent from the following description of the preferred embodiment taken in conjunction with the following drawings, although variations and modifications therein may be affected without departing from the spirit and scope of the novel concepts of the disclosure.

BRIEF DESCRIPTION OF THE DRAWINGS

The accompanying drawings illustrate one or more embodiments of the invention and, together with the written

description, serve to explain the principles of the invention. Wherever possible, the same reference numbers are used throughout the drawings to refer to the same or like elements of an embodiment, and wherein:

FIG. 1(a)-1(e) show schematically a liquid crystal display (LCD) with an integrated touch sensing device according to one embodiment of the present invention: 1(a) a partially top view, 1(b)-1(d) a partially cross-sectional view along A-A', B-B' and C-C' lines, respectively, and 1(e) a partially cross-sectional view;

FIG. 2(a)-2(c) show schematically 2(a)-2(c) different cross-sectional views of an LCD with an integrated touch sensing device according to another embodiment of the present invention;

FIG. 3(a)-3(c) show schematically a fabricating process of an LCD with an integrated touch sensing device according to one embodiment of the present invention;

FIG. 4 shows schematically 4(a) a set of display units of an LCD and 4(b) a matrix of sensor units integrated with the LCD according to one embodiment of the present invention, and

FIG. 5 shows schematically cross sectional view corresponding to FIG. 4.

DETAILED DESCRIPTION OF THE INVENTION

The present invention is more particularly described in the following examples that are intended as illustrative only since numerous modifications and variations therein will be apparent to those skilled in the art. Various embodiments of the invention are now described in detail. Referring to the drawings, like numbers indicate like components throughout the views. As used in the description herein and throughout the claims that follow, the meaning of "a", "an", and "the" includes plural reference unless the context clearly dictates otherwise. Also, as used in the description herein and throughout the claims that follow, the meaning of "in" includes "in" and "on" unless the context clearly dictates otherwise.

The description will be made as to the embodiments of the present invention in conjunction with the accompanying drawings in FIGS. 1-5. In accordance with the purposes of this invention, as embodied and broadly described herein, this invention, in one aspect, relates to an LCD having a touch sensing device integrated thereon.

FIGS. 1(a)-1(e) show schematically an LCD 100 with an integrated touch sensing device according to one embodiment of the present invention. The LCD 100 includes a first substrate 110 and a second substrate 180 arranged to be substantially parallel to and apart from the first substrate 110. Typically, the first substrate 110 and the second substrate 180 are separated from one another with one or more spacers. The first substrate 110 and the second substrate 180 are formed of a transparent material such as glass.

The LCD 100 also includes a touch sensing device having a first coordinate detecting layer 120 including a plurality of X electrodes 125 parallel and regular-spacingly formed on the first substrate 110 and connected by connection lines 135X along an X-direction, an insulating layer 130 formed on the first coordinate detecting electrode layer 120, and a second coordinate detecting layer 140 including a plurality of Y electrodes 145 parallel and regular-spacingly formed on the insulating layer 130 and connected by connection lines 135Y along a Y-direction that is substantially perpendicular to the X-direction. The insulative layer 130 is formed of a transparent, non-conductive material, or a non-transparent, non-conductive material. The plurality of X electrodes 125 and the

plurality of Y electrodes **145** are adapted for detecting a location of a touch point in the first substrate **110**. In this embodiment as shown in FIGS. **1(a)**-**1(d)**, the touch sensing device has two conductive layers for connection lines **135X** and **135Y** in the crossover portions for the plurality of X electrodes **125** and the plurality of Y electrodes **145**, and a single conductive layer in the other portions. In a modified embodiment, the first coordinate detecting layer **120** and the second coordinate detecting layer **140**, the touch sensing device is effectively formed with a single conductive layer excepting the connection lines **135X** and **135Y** in the crossover portions.

The LCD **100** further includes a color filtering matrix having a plurality of red (R), green (G) and blue (B) color pads **150**. Each color pad **150** is formed on the first substrate **110** in a corresponding space defined by X electrodes **125** and Y electrodes **145**. The LCD **100** also includes a transparent overcoat layer **160** formed on the color filtering matrix and uncovered portions of the insulating layer **130** and the plurality of Y electrodes **145**. Furthermore, a common electrode **170** is formed on the transparent overcoat layer **160**. The common electrode **170** is formed of a thin transparent layer of a transparent, conductive material, such as ITO. Each of the plurality of X electrodes **125** and the plurality of Y electrodes **145** is configured to capacitively couple to a human's finger, and associated with coordinates of the first substrate **110** at which the electrode is located, such that when a user's finger touches to the first substrate **110**, a capacitively coupled R-C circuit from one or more of the plurality of X electrodes **125** and the plurality of Y electrodes **145** to the human body is established, thereby causing current variation from the one or more electrodes at the touch point. By measuring the current variation, the location of the touch point can be derived.

Furthermore, the LCD **100** includes a pixel layer **190** having a plurality of pixel electrodes **195** and a plurality of semiconductor devices **191** formed on the second substrate **190**, and a liquid crystal material **199** disposed between the common electrode **170** and the pixel layer **190**, as shown in FIG. **1(e)**. Each semiconductor device **199** may include a liquid crystal capacitor, a storage capacitor, and a thin film transistor (TFT), which is electrically coupled to a corresponding pixel electrode, liquid crystal capacitor and storage capacitor. Additionally, a plurality of data lines and a plurality of gate lines (not shown) are formed on the second substrate **180** in the area where no pixel electrode **195** is formed. The plurality of data lines and a plurality of gate lines are adapted for connecting the plurality of pixel electrodes **195** and the plurality of semiconductor devices **199** to a gate driver and a data driver, respectively.

The first substrate **110** and the second substrate **180** are aligned such that each color pad **150** on the first substrate **110** is positioned opposite a corresponding pixel electrode **195** on the second substrate **180**, and the plurality of X electrodes **125** and the plurality of Y electrodes **145** on the first substrate **110** are positioned opposite the plurality of semiconductor devices **199** on the second substrate **180**, as shown in FIG. **1(e)**. The plurality of X electrodes **125** and the plurality of Y electrodes **145** are formed of a non-transparent, conductive material such as chromium and/or chromium oxide, or other suitable material that has low reflectivity and blocks the transmission of light. An additional anti-reflective material or low reflective material (not shown) can be formed on the X electrodes **125** and the Y electrodes **145** to reduce light reflecting. In this configuration, the plurality of X electrodes **125** and the plurality of Y electrodes **145** have dual functions of touch sensors and a black matrix.

Such a configuration not only makes the overall LCD device thinner, thereby reducing the size and weight of the LCD device, but also enhances light transmission for the coordinate display panel because of using fewer elements comparing to conventional touch sensing LCD devices.

FIGS. **2(a)**-**2(c)** shows schematically another embodiment of an LCD **200** with an integrated touch sensing device according to the present invention. The structure of the LCD **200** is similar to that of the LCD **100** as shown in FIGS. **1(a)**-**1(e)**, except that the touch sensing device is formed on a second surface **214** of a first substrate **210**, which is opposite a first surface **212** of the first substrate **210** on which a color matrix **250** is formed. In the exemplary embodiment, the touch sensing device includes a plurality of X electrodes **225** parallel and regular-spacingly aligned and connected by connection lines **235X** along an X-direction, and a plurality of Y electrodes **245** parallel and regular-spacingly aligned and connected by connection lines **235Y** along a Y-direction that is substantially perpendicular to the X-direction. Additionally, an insulating layer **230** is deposited between the plurality of X electrodes **225** and the plurality of Y electrodes **245**. An overcoat layer **280** can be formed of transparent, insulative material on the touch sensing device.

On the other surface **212** of the first substrate **210**, the color matrix including a plurality of R, G, B color pads **150** is deposited such that the location of each color pad **250** is opposite a corresponding area defined by two neighboring X electrodes **225** and two neighboring Y electrodes **245** crossover the two neighboring X electrodes **225** on the second surface **214** of the first substrate **210**. The color matrix is covered by a transparent, non-conductive layer **260**. A common electrode **270** is then formed on the transparent, non-conductive layer **260**. The plurality of X electrodes **225** and the plurality of Y electrodes **245** are configured to capacitively couple to the common electrode **270** for detection of a location of a touch point. Therefore, when a user's finger touches to the overcoat layer **280**, a capacitively coupled R-C circuit from one or more of the plurality of X electrodes **225** and the plurality of Y electrodes **245** to the human body is established, thereby causing current variation from the one or more electrodes at the touch point, which are measured and adapted for detection of the location of the touch point.

Additionally, the touch sensing device may act as a black matrix, when the plurality of X electrodes **225** and the plurality of Y electrodes **245** formed of a non-transparent, conductive material.

Referring to FIGS. **3(a)**-**3(c)**, a fabricating process **300** of a touch sensing device integrated with a color matrix is schematically shown according to one embodiment of the present invention. First, at step **301**, a transparent glass substrate **310** is provided. Then at step **302**, a first non-transparent, conductive material is deposited on the substrate **310** to form a first coordinate detecting layer **320** thereon. The first coordinate detecting layer **320** is patterned into a plurality of X electrodes **325** parallel and regular-spacingly and connected by connection lines **335X** along an X-direction. Each X electrodes **325** define a plurality of spaces **322** therein. At step **303**, an electrically non-conductive material is deposited on the first coordinate detecting layer **320** to form an insulative layer **330** thereon. At step **304**, a second non-transparent, conductive material is deposited on the insulative layer **330** to form a second coordinate detecting layer **330** thereon. The second coordinate detecting layer **330** is then patterned into a plurality of Y electrodes **345** parallel and regular-spacingly and connected by connection lines **335Y** along a Y-direction that is perpendicular to the X-direction. Each Y electrodes **345** define a plurality of spaces **352** therein. The patterned X

and Y electrodes **325** and **345** define a matrix of spaces **322** and **352**. The first and second non-transparent, conductive materials can be an identical material or two substantially different materials.

At step **305**, a color matrix having a plurality of R, G, B color pads is formed of R, G, B color materials on the first substrate **310** such that each color pad **350** of a corresponding color material is deposited into a corresponding space **352** defined by X electrodes **325**, Y electrodes **345** and connection lines **335X**, **335Y**.

At step **306**, a transparent, non-conductive material is deposited on the color matrix to form an overcoat layer **360** thereon. At step **307**, a common electrode layer **370** is formed of a transparent, conductive material, such as ITO, on the overcoat layer **360**.

FIG. **4** shows schematically an LCD **400** with an integrated touch sensing device according to another embodiment of the present invention. FIG. **5** shows schematically cross sectional view corresponding to FIG. **4** in adjacent X, Y electrodes and crossover portion. The LCD **400** includes a first substrate, a color matrix formed on the first substrate, and a common electrode formed on the color matrix, a second substrate spaced from the first substrate, a pixel electrode matrix formed on the second substrate, a liquid crystal material disposed between the common electrode and the pixel electrode matrix. The color matrix includes a plurality of R, G, and B color pads and is formed between the first substrate and the common electrode. The pixel electrode matrix, together with the color matrix, defines a matrix of display units **410**, which is partially shown in FIG. **4(a)**. In other words, each display unit **412** is associated with a pixel electrode of the pixel electrode matrix and a corresponding color pad of the color matrix, and therefore with coordinates of the LCD panel.

The touch sensing device **420** includes a matrix of touch sensor units **422** that include a plurality of X electrodes **425** connected in series by a plurality of connection lines **435X** along an X-direction (row) and a plurality of Y electrodes **445** connected in series by a plurality of connection lines **435Y** along a Y-direction (column), as shown in FIG. **4(b)**. Each connection lines **435X**, **435Y** is electrically connected to external circuit by a plurality of control lines **415**. In this embodiment, each touch sensor unit **422** has four touch sensors {Y, X; X, Y}, i.e. X electrodes **425** and Y electrodes **445**, forming a two by two matrix aligned in the X-direction and the Y-direction, where each two diagonal touch sensors (Y-Y and X-X) are electrically connected. The connection lines **435X** and **435Y** are narrowed only between two adjacent display units **412**. Each touch sensor (X or Y) is made of a non-transparent, conductive material such as chromium or the like. The matrix of touch units **422** is formed on a side of the first substrate of the LCD, which is opposite the side of the first substrate on which the color matrix is formed. Alternatively, the matrix of touch units **422** can be formed on the same side of the first substrate as that on which the color matrix is formed. The matrix of touch units **422** is configured to capacitively couple to the user's finger and associated with the matrix of display units **410**. The touch sensing device **420** may include an overcoat layer **411** formed of a transparent, non-conductive material on the matrix of touch sensor units **422**.

In this exemplary embodiment of FIG. **4**, each touch sensor (X or Y) is associated with six by twelve display units **412**. When a user's finger touches to the substrate **411**, a capacitively coupled path (R-C circuit) from the touch point (sensor) to the user's finger is established, thereby, generating a current variant from the touch point (sensor). The location of

the touch point (sensor) is detectable by measuring the current variation. Then, a function, if any, associated with the touch location is displayed on the display units **410** of the LCD associated with the touch unit **412**.

The present invention, among other things, discloses an LCD having a dual functional touch sensing device integrated with a color matrix of the LCD.

The foregoing description of the exemplary embodiments of the invention has been presented only for the purposes of illustration and description and is not intended to be exhaustive or to limit the invention to the precise forms disclosed. Many modifications and variations are possible in light of the above teaching.

The embodiments were chosen and described in order to explain the principles of the invention and their practical application so as to activate others skilled in the art to utilize the invention and various embodiments and with various modifications as are suited to the particular use contemplated. Alternative embodiments will become apparent to those skilled in the art to which the present invention pertains without departing from its spirit and scope. Accordingly, the scope of the present invention is defined by the appended claims rather than the foregoing description and the exemplary embodiments described therein.

What is claimed is:

1. A liquid crystal display (LCD), comprising:

- a first substrate;
- a first coordinate detecting layer having a plurality of X electrodes and a plurality of first connection lines, the X electrodes being parallel to each other and regular-spacingly formed on the first substrate along an X-direction, and the X electrodes being connected by the first connection lines therebetween;
- an insulating layer formed on the first coordinate detecting electrode layer;
- a second coordinate detecting layer having a plurality of Y electrodes and a plurality of second connection lines with a plurality of openings, the Y electrodes being parallel to each other and regular-spacingly formed on the insulating layer along a Y-direction that is substantially perpendicular to the X-direction, the Y electrodes being connected by the second connection lines therebetween, each of the plurality of X electrodes and the plurality of Y electrodes being formed of a non-transparent, conductive material, the X electrodes and the Y electrodes being not overlapped, the first connection lines and the second connection lines being overlapped and insulated by the insulating layer, wherein the first coordinate detecting layer, the insulating layer and the second coordinate detecting layer define a plurality of openings exposing the first substrate, and the plurality of X electrodes, the plurality of Y electrodes, the first connection lines and the second connection lines are configured to be a black matrix with the openings;
- a color filtering matrix having a plurality of color pads, each color pad formed in one of the plurality of openings correspondingly;
- a transparent overcoat layer formed on the color filtering matrix, the insulating layer and the plurality of Y electrodes;
- a second substrate spaced from the first substrate;
- a pixel layer having a plurality of pixel electrodes and a plurality of semiconductor devices formed on the second substrate; and
- a liquid crystal material disposed between the common electrode and the pixel layer.

2. The LCD of claim 1, wherein each of the first substrate and the second substrate is formed of a transparent material.

3. The LCD of claim 1, wherein the insulating layer is formed of a non-conductive material.

4. The LCD of claim 1, wherein each of the plurality of semiconductor devices comprises a thin film transistor (TFT), electrically coupled to a corresponding pixel electrode.

5. The LCD of claim 1, wherein the first substrate and the second substrate are aligned such that each color pad on the first substrate is positioned opposite a pixel electrode correspondingly on the second substrate.

6. The LCD of claim 1, wherein each of the plurality of X electrodes and the plurality of Y electrodes is associated with coordinates of the first substrate at which the electrode is located.

7. The LCD of claim 1, wherein when the first substrate is touched, the touch location at the first substrate is detectable by measuring a signal generated responsively by one or more of the plurality of X electrodes and the plurality of Y electrodes at the touch location.

8. The LCD of claim 1, further comprising a common electrode formed on the transparent overcoat layer.

9. The LCD of claim 8, wherein the common electrode is formed of a layer of a transparent, conductive material.

10. The LCD of claim 1, wherein when the first substrate is touched, the touch location at the first substrate is detectable by measuring a signal generated responsively by one or more of the plurality of X electrodes and the plurality of Y electrodes at the touch location.

11. A liquid crystal display (LCD), comprising:

a first substrate having a first surface and a second surface opposite to the first surface;

a touching sensing member formed on the second surface of the first substrate, the touch sensing member comprising a plurality of X electrodes, a plurality of Y electrodes, a plurality of first connection lines, a plurality of second connection lines and an insulating layer, the X electrodes being parallel to each other and regular-spacingly aligned along the X-direction, the X electrodes being connected by the first connection lines therebetween, the plurality of Y electrodes being parallel to each other and regular-spacingly aligned along the Y-direction, the Y electrodes being connected by the second connection lines therebetween, the X electrodes and the

Y electrodes being not overlapped, the first connection lines and the second connection lines being overlapped, the insulating layer being formed between the first connection lines and the second connection lines, each of the plurality of X electrodes and the plurality of Y electrodes being formed of a non-transparent, conductive material, wherein the first coordinate detecting layer, the insulating layer and the second coordinate detecting layer define a plurality of openings exposing the first substrate;

a color filtering layer formed on the first surface of the first substrate, the color filtering layer being patterned in the form of a color matrix having a plurality of color pads, each of the color pads being aligned to one of the plurality of openings correspondingly;

a transparent overcoat layer formed on the color filtering layer;

a second substrate spaced from the first substrate and facing to the first surface of the first substrate;

a pixel electrode layer formed on the second substrate; and a liquid crystal material disposed between the common electrode and the pixel electrode layer.

12. The LCD of claim 11, wherein the insulating layer is formed of a non-conductive material.

13. The LCD of claim 11, wherein the touch sensing member further comprises an overcoat layer formed over the plurality of X electrodes and the plurality of Y electrodes.

14. The LCD of claim 11, further comprising a black matrix interleaved with the plurality of color pads.

15. The LCD of claim 11, wherein each of the first substrate and the second substrate is formed of a transparent material.

16. The LCD of claim 11, wherein the insulating layer is formed of a non-conductive material.

17. The LCD of claim 11, further comprising a common electrode formed on the transparent overcoat layer.

18. The LCD of claim 17, wherein the common electrode is formed of a layer of a transparent, conductive material.

19. The LCD of claim 11, wherein when the first substrate is touched, the touch location at the first substrate is detectable by measuring a signal generated responsively by one or more of the plurality of X electrodes and the plurality of Y electrodes at the touch location.

摘要(译)
