(57) **ABSTRACT**

The present invention relates to an in-plane switching mode LCD and a method of manufacturing the same, in which data electrodes and common electrodes in a unit pixel have the same light transmitting area to reduce the luminance difference according to positive or negative polarity of an applied DC voltage. The in-plane switching mode LCD comprises first and second substrates; a plurality of pixel areas defined on the first substrate; data electrodes and common electrodes alternately formed in each of the pixel areas and patterned to have the same light transmitting area according to the applied voltage; and a liquid crystal layer between the first and second substrates. The method of manufacturing comprises: preparing the first and second substrates; forming a plurality of gate lines and data lines on the first substrate to define a plurality of pixel areas; forming a plurality of data electrodes and common electrodes to be alternately formed in each pixel areas and have the same light transmitting area in applying voltage; and forming a liquid crystal layer between the first and second substrates.








































IN-PLANE SWITCHING MODE LIQUID CRYSTAL DISPLAY DEVICE AND METHOD OF MANUFACTURING THE SAME

[0001] This application claims the benefit of Korean Patent Application No. 2000-61934 filed on Oct. 20, 2000 which is hereby incorporated by reference as if fully set forth herein.

BACKGROUND OF THE INVENTION

[0002] 1. Field of the Invention

[0003] The present invention relates to an Liquid Crystal Display (LCD) Device, and more particularly, to an in-plane switching mode LCD and a method of manufacturing the same.

[0004] 2. Discussion of the Related Art

[0005] Twisted Nematic (TN) mode LCDs are generally used in current LCD devices. In the TN technique, electrodes are installed on each of two substrates and a liquid crystal (LC) director is arranged as a twisted 90°, then voltage is applied to the electrodes to drive the LC director.

[0006] However, TN mode LCDs have the disadvantage that the phase of light passing through the liquid crystal cell varies according to the direction of the light, causing a narrow viewing angle.

[0007] Recently, techniques have been actively developed for solving such a problem of the narrow viewing angle. Techniques for widening the viewing angle include a film-compensated mode for compensating the viewing angle with a compensating film, a multi-domain mode for dividing one pixel into several domains to vary the main viewing angle direction of each domain so that the pixel characteristic becomes the mean value of the several domain characteristics; an in-plane switching mode for applying a parallel electric field to twist the LC director in a plane parallel to an orientation film; a Vertical Alignment (VA) mode for using a negative liquid crystal and a vertically oriented film to vertically arrange the long axis of liquid crystal molecules about the oriented film; an Optically Compensated Birefringence (OCB) mode, and the like.

[0008] In the in-plane switching mode LCD, two electrodes are formed on one substrate for rotating the liquid crystal molecules in a plane parallel to the substrate. Voltage is applied between the two electrodes to induce an electric field parallel to the substrate, thereby reducing variation in birefringence of the liquid crystal.

[0009] Therefore, the in-plane switching mode LCD has excellent viewing angle characteristics compared to the TN mode LCD of the related art.

[0010] Hereinafter the in-plane switching mode LCD of the related art will be described with reference to the appended drawings as follows:

[0011] FIG. 1A is a plan view showing an in-plane switching mode LCD of the related art. FIG. 1B shows a cross section along line I-I' in FIG. 1A, and FIG. 1C shows a cross section along line II-II' in FIG. 1A.

[0012] FIG. 2A is a plan view for showing a general structure of an ITO-ITO electrode of the in-plane switching LCD. FIG. 2B shows transmitting and shielding areas of the

ITO-ITO electrode of the in-plane switching LCD when positive DC voltage is applied to a data electrode. FIG. 2C shows the transmitting and shielding areas of the ITO-ITO electrode of the in-plane switching LCD when negative DC voltage is applied to the data electrode.

[0013] The general in-plane switching mode LCD as shown in FIG. 1A comprises data lines 10 and gate lines 11 arranged on a first substrate for defining a pixel area, a common line 12 arranged in the pixel area parallel to the gate lines 11, a thin film transistor placed in intersecting regions of the gate lines 11 and the data lines 10, data electrodes 14 arranged parallel to the data lines 10 in the pixels, common electrodes 13 extended from the common lines 12 and arranged between the data electrodes 14, and storage electrodes 55 extended from the data electrodes 14 and formed in the upper parts of the gate lines 11.

[0014] Referring also to FIG. 1B, the in-plane switching mode LCD is formed by joining the first substrate 18 and the second substrate 19 together in opposition to each other and injecting a liquid crystal layer 30 between the two substrates. The gate lines 11 are formed parallel to the common lines 12 on the first substrate 18. The common electrodes 13, which extend from the common lines 12, are commonly formed with the common lines 12. Here, a portion of the gate lines 11 functions as gate electrodes of the thin film transistor.

[0015] Then, a silicon nitride (SiNx) or a silicon oxide (SiOx) film is applied to the surface, including the gate lines 11 and the common electrodes 13, to form a gate insulation film 20, and a semiconductor layer 15 is formed on a portion of the gate insulation film as an active layer.

[0016] Next, the data lines 10 are formed on top of the gate insulation film 20 to form a matrix shape with the gate lines 11, and source/drain electrodes 16 and 17 are simultaneously formed to extend from the data lines 10 and be placed on a semiconductor layer 15. Here, the data electrodes 14 parallel to the common electrodes 13 and the storage electrodes 55 are formed at the same time, which connect the data electrodes 14.

[0017] The gate electrodes, the gate insulation film 20, the semiconductor layer 15, the source/drain electrodes 16 and 17 form the thin film transistor.

[0018] Then, a silicon oxide film, a silicon nitride film or an organic insulation film such as a BCB (Benzocyclobutene) film is applied on the surface, including the data lines 10, to form a protective film 25.

[0019] In the in-plane switching LCD, the common electrodes and the data electrodes can be formed on different planes, with the insulation film sandwiched as above or can be formed on one plane.

[0020] Also, the common electrodes and the data electrodes can be formed simultaneously with the lines made of metals including Cu, Al, Cr, Mo, Ti, Al alloy and the like for shielding a light, or a transparent conductive material such as ITO (Indium Tin Oxide) can be used in forming the same by further using a mask. When forming the electrodes using a mask, however, care should be used to avoid a short between the lines or electrodes.

[0021] When the data electrodes 14 and the common electrodes 13 are formed of ITO, which is a transparent conductive film that is excellent in transmitting light, the

LCD is called an ITO-ITO in-plane switching LCD. A general structure of an ITO-ITO electrode is shown in **FIG. 2**.

[0022] A black matrix **21** is formed on the second substrate **19** to prevent light leakage, and an R, G, B color filter layer **22** is formed between the black matrix **21**.

[0023] An overcoat layer **23** is formed on top of the color filter layer **22** to protect and planarize the color filter layer **22**.

[0024] The ITO-ITO in-plane switching LCD formed as above has a horizontal or parallel electric field rather than a vertical electric field between the data and common electrodes, a vertical electric field in a middle portion of the electrodes, and horizontal or parallel and vertical electric fields commonly formed at corners of the electrodes.

[0025] Initially, the liquid crystal molecules between the electrodes are rotated parallel to the substrate due to a side electric field. After a certain time period, the liquid crystal molecules on the electrodes are rotated due to the vertical and side electric fields and an elastic force of the liquid crystal at the electrodes.

[0026] In an ITO-ITO in-plane switching LCD, the liquid crystal molecules on the electrodes have an orientation according to positive or negative voltage applied to the electrodes, thereby causing light transmissivity to be different at the data electrodes and the common electrodes.

[0027] In other words, when a positive DC voltage is applied to the data electrodes and a negative DC voltage is applied to the common electrodes, light is transmitted in a larger amount at the common electrodes than at the data electrodes, as shown in **FIG. 2B**. Also, when a negative DC voltage is applied to the data electrodes and a positive DC voltage is applied to the common electrodes, light is transmitted in a larger amount at the data electrodes **14**, as shown in **FIG. 2C**.

[0028] In other words, a luminance difference is created at each electrode depending on whether a positive or negative voltage is applied.

[0029] As shown herein before, the foregoing in-plane switching LCD of the related art has the following problems.

[0030] To reduce degradation due to malfunction of the liquid crystal and to improve definition (picture quality), the common electrodes at the outermost position in the pixels are opposed and shielded with the black matrix layer on the substrate. Thus, the common electrodes and the data electrodes in a unit pixel have different the transmitting areas, which causes a luminance difference according to positively or negatively applied voltage. Flickers and residual images are generated because of the luminance difference, thus lowering reliability of the display device.

SUMMARY OF THE INVENTION

[0031] Accordingly, the present invention is directed to an in-plane switching mode liquid crystal display device and method of manufacturing the same that substantially obviates one or more of the problems due to limitations and disadvantages of the related art.

[0032] It is therefore an object of the invention to provide an in-plane switching mode LCD in which the light trans-

mitting area the same with respect to data electrodes and common electrodes to improve definition (picture quality), and a manufacturing method thereof.

[0033] Additional features and advantages of the invention will be set forth in the description which follows, and in part will be apparent from the description, or may be learned by practice of the invention. The objectives and other advantages of the invention will be realized and attained by the structure particularly pointed out in the written description and claims hereof as well as the appended drawings.

[0034] To achieve these and other advantages in accordance with the purpose of the present invention, as embodied, and broadly described, An in-plane switching liquid crystal display device, comprises first and second substrates; a plurality of data lines on the first substrate; a plurality of gate lines crossing the data lines on the first substrate, perpendicular to the data lines; a plurality of pixel areas on said first substrate defined by the data and gate lines; data electrodes and common electrodes alternately formed in each of said pixel areas, the data electrodes having a first transmittance area and the common electrodes having a second transmittance area, wherein the first transmittance area equals the second transmittance area; and a liquid crystal layer between said first and second substrates.

[0035] In another aspect of the present invention, an in-plane switching mode LCD comprises: first and second substrates; a plurality of pixel areas on the first substrate; data electrodes and common electrodes alternately formed in each of the pixel areas and patterned to have the same light transmitting area according to applied voltage; and a liquid crystal layer between the first and second substrates.

[0036] In another aspect of the present invention, a method of manufacturing an in-plane switching mode LCD includes the preparing the first and second substrates; forming a plurality of gate lines and data lines on the first substrate to define a plurality of pixel areas; forming a plurality of data electrodes and common electrodes to be alternately formed in each pixel and have the same light transmitting area in applying voltage; and forming a liquid crystal layer between the first and second substrates.

[0037] It is to be understood that both the foregoing general description and the following detailed description are exemplary and explanatory and are intended to provide further explanation of the invention as claimed.

BRIEF DESCRIPTION OF THE DRAWINGS

[0038] The accompanying drawings, which are included to provide a further understanding of the invention and are incorporated in and constitute a part of this specification, illustrate embodiments of the invention and together with the description serve to explain the principles of the invention.

[0039] In the drawings:

[0040] **FIG. 1A** is a plan view an in-plane driving mode LCD of the related art;

[0041] **FIG. 1B** shows a cross section along a line I-I' of **FIG. 1A**;

[0042] **FIG. 1C** shows a cross section along a line II-II' of **FIG. 1A**.

[0043] **FIG. 2A** is a plan view for showing a general structure of an ITO-ITO electrode of the in-plane switching LCD;

[0044] **FIG. 2B** shows transmitting and shielding areas when a positive DC voltage is applied to a data electrode;

[0045] **FIG. 2C** shows the transmitting and shielding areas when a negative DC voltage is applied to the data electrode;

[0046] **FIG. 3A** is a plan view of an embodiment of an in-plane switching mode LCD of the present invention;

[0047] **FIG. 3B** shows a cross section along a line III-III' of **FIG. 3A**;

[0048] **FIG. 4A** shows a cross section of a main part of an in-plane switching mode LCD according to a first embodiment of the present invention;

[0049] **FIG. 4B** shows a cross section of a main part of an in-plane switching mode LCD according to a second embodiment of the present invention;

[0050] **FIG. 4C** shows a cross section of a main part of an in-plane switching mode LCD according to a third embodiment of the present invention;

[0051] **FIG. 5** shows a screen on a display according to one of the first to fourth embodiments of the present invention;

[0052] **FIGS. 6A and 6B** show a cross sections of a main part of an in-plane switching mode LCD according to the fifth embodiment of the present invention;

[0053] **FIGS. 7A and 7B** show a cross sections of a main part of an in-plane switching mode LCD according to the sixth embodiment of the present invention;

[0054] **FIGS. 8A and 8B** shows a cross section of a main part of an in-plane switching mode LCD according to the seventh embodiment of the present invention; and

[0055] **FIGS. 9** shows a screen on a display according to one of the fifth to seventh embodiments of the present invention.

DETAILED DESCRIPTION OF THE PREFERRED EMBODIMENT

[0056] Reference will now be made in detail to the preferred embodiment of the present invention, example of which is illustrated in the accompanying drawings.

[0057] **FIG. 3A** is a plan view showing an in-plane switching mode LCD of the present invention, and **FIG. 3B** shows a cross section along line III-III' in **FIG. 3A**.

[0058] **FIG. 4A** shows a cross section of a main part of an in-plane switching mode LCD according to the first embodiment of the present invention. **FIG. 4B** shows a cross section of a main part of an in-plane switching mode LCD according to the second embodiment of the present invention. **FIG. 4C** shows a cross section of a main part of an in-plane switching mode LCD according to the third embodiment of the present invention.

[0059] **FIG. 5** shows a screen on a display according to one of the first to fourth embodiments of the invention.

[0060] First, explaining the method of manufacturing the in-plane switching mode LCD according to the first embodiment in reference to **FIG. 3A** to **FIG. 3B**, a low resistance metal layer is deposited and patterned to form gate lines 111 and a gate electrode 111a, which extends from the gate lines 111 and is the gate electrode of a thin film transistor.

[0061] Then, a silicon nitride (SiNx) or a silicon oxide (SiOx) film is deposited on the surface of the gate lines 111 to form a gate insulation film 120, and a semiconductor layer 115 is formed on the gate insulation film 120 over the gate electrodes 111a using amorphous silicon.

[0062] Then, a low resistance metal is deposited on the gate insulation film 120 followed and patterned to form data lines 110 in a matrix with the gate lines 111, so that data lines 110 together with the gate lines define a unit pixel area.

[0063] Here, source/drain electrodes 116 and 117 of a thin film transistor are formed simultaneously with the data lines 110.

[0064] Here, the gate electrodes, gate insulation film, semiconductor layer, source/drain electrodes from the thin film transistor.

[0065] Then, as shown in **FIG. 4A**, shielding layers 215b are formed under a position where the outermost ones of common electrodes 213 in a unit pixel will be formed later. A shielding layer 215a is formed under a position where one of the data electrodes 214 in the unit pixel will be formed later, so that the common electrodes and the data electrodes in the unit pixel have the same light transmitting area.

[0066] The data lines are formed of metals including Cu, Al, Cr, Mo, Ti, Al alloy and the like for shielding light, therefore an additional process is not necessary to form shielding layers 215a and 215b under the common electrodes and the data electrodes.

[0067] Here, the outermost common electrodes in the unit pixel are shielded to reduce the influence of the electric field at both ends in the unit pixel about the liquid crystal, where the behavior of the liquid crystal is unclear when voltage is applied. Because the electric field between the outermost common electrode and an adjacent unit pixel data line is unknown, the outermost common electrode is shielded by a black matrix. In addition instead of being formed of ITO, the outermost common electrodes can be formed of an opaque metal that can shield light. Alternatively, the black matrix on the second substrate can be extended to the area of the outermost common electrodes.

[0068] Then, the plurality of data electrodes 214 are formed and are electrically connected with the drain electrode 117 and parallel to the data lines; and the common electrodes 213 are formed at the positions corresponding to positions between the data electrodes 214. That is, the data electrodes 214 and the common electrodes 213 have an alternating pattern.

[0069] Here, the common electrodes 213 can be formed under the data electrodes 214, i.e., on a layer different from the data electrodes 214 as shown in **FIG. 4B**. Alternatively the common electrodes 213 can be formed with the data electrodes, i.e., on the same layer as the data electrode 214 as shown in **FIG. 4C**.

[0070] Referring again to **FIG. 3B**, meanwhile, a black matrix 121 is formed on the second substrate 119 for

preventing leakage of light, and a color filter layer 122 is formed between the black matrix 121.

[0071] Finally, the first substrate 118 and the second substrate 119 are assembled to oppose each other, and a liquid crystal layer 130 is injected between the substrates 118 and 119 to complete the in-plane switching mode LCD.

[0072] Here, the data electrodes 214 and the common electrodes 213 are formed of ITO which is a transparent conductive film excellent in transmitting light.

[0073] In such an in-plane switching mode LCD of the invention, the light transmitting area through the data electrodes and the light transmitting area through the common electrodes are the same even if the outermost common electrodes in the unit pixel are shielded, so that the luminance difference due to a positive or negative applied DC voltage is prevented.

[0074] Meanwhile, as the fourth embodiment of the invention, the outermost common electrodes in the unit pixel can be formed of a shielding metal capable of shielding a light instead of the transparent conductive film. In this case, it is unnecessary to form an additional shielding layer or to extend the black matrix.

[0075] The first to fourth embodiments of the invention, as discussed above, have the alternating common electrodes 213 and data electrodes 214 in the unit pixel area. At least one data electrode 214a of the data electrodes in the unit pixel is shielded to make the common electrodes have the same light transmitting area as the data electrodes, so that the difference between the light transmitting areas of the common electrodes and the data electrodes occurring when the outermost common electrodes 213a are shielded as shown in **FIG. 5**.

[0076] Meanwhile, **FIGS. 6A and 6B** show a cross sections of a main part of an in-plane switching mode LCD according to the fifth embodiment of the invention. **FIGS. 7A and 7B** show a cross section of a main part according to the sixth embodiment of the invention. **FIGS. 8A and 8B** show a cross section of a main part of an in-plane switching mode LCD according to the seventh embodiment of the invention, in which width of at least one common electrode is patterned wider than that of data electrodes.

[0077] In other words, instead of one of the data electrodes being shielded according to the first to fourth embodiments of the present invention, one of the common electrodes is formed wider in width than the data electrodes of the fifth to seventh embodiments of the present invention, so that the common electrodes and the data electrodes have the same light transmitting area. For example, one common electrode can be formed to be twice the width of one of the data electrodes, so that, e.g., two common electrodes that transmit light can have the same area as three data electrodes that transmit light. Alternatively, two common electrodes can be formed to be 1.5 times the width of one of the data electrodes, so that, e.g., two common electrodes can have the same area as three data electrodes.

[0078] As not shown in the drawings, gate lines and gate electrodes are formed on the first substrate. A gate insulation film is formed on the surface including the gate lines. Then, the semiconductor layer is formed on the gate insulation film on the gate electrodes.

[0079] Then, data lines are formed on the gate insulation film to form a matrix with the gate lines to define unit pixel areas. Source and drain electrodes are formed at the same time as the data lines.

[0080] Here, the gate electrodes, gate insulation film, semiconductor layer, source and drain electrodes form the thin film transistor.

[0081] Consequently, when the data lines are formed, a plurality of data electrodes 314 are formed to be electrically connected with the drain electrode and parallel to the data lines and the common electrodes 313a and 313b. Shielding layers 315b are formed of the same material as that of the data lines to be under some outermost ones of a plurality common electrodes 313a and 313b which will be formed later. The common electrodes 313a and 313b alternate with the data electrodes 314. At least one of the plurality of common electrodes is formed wider in width than that of the adjacent data electrode.

[0082] For example, when the common electrodes and the data electrodes have substantially the same width and the number of the data electrodes is one more than that of the common electrodes, one of the common electrodes is formed to have two times the width of the data lines, so that the common electrodes and the data electrodes have the same light transmitting area overall.

[0083] Here, an insulation film 325, on which the data electrodes 314 can be formed, may be formed on the surface including the common electrodes 313a and 313b as shown in **FIG. 6B**, and the common electrodes 313a and 313b can be formed with the data electrodes 314.

[0084] Meanwhile, a black matrix is formed on the second substrate for preventing light leakage, and a color filter layer is formed in the black matrix as not shown in the drawings.

[0085] Finally, the first and second substrates are assembled to oppose each other, and a liquid crystal layer is injected between the two substrates to complete the in-plane switching mode LCD.

[0086] Here, the data electrodes 314 and the common electrodes 313 are ITO, except that the outermost common electrodes, shown in **FIG. 6A** to **FIG. 6C**, can be formed of a shielding metal which can shield light.

[0087] According to the fifth to seventh embodiments of the present invention as described herein before, the common electrodes are patterned wider than the data electrodes so that the common electrodes and the data electrodes have the same light transmitting area, as shown in **FIG. 9**.

[0088] The non-shielded area of the common electrodes is smaller than the area of the data electrodes because the outermost common electrodes are shielded. Thus, according to the present invention the common electrodes are patterned wider to have the same area as the data electrodes.

[0089] In reference, the data electrodes and the common electrodes can be formed in various forms such as a zigzag type instead of a stripe type.

[0090] Such a method of manufacturing the in-plane switching mode LCD according to the invention has the following effects:

[0091] First, the data electrodes and the common electrodes in the unit pixel have the same light transmitting area to eliminate the luminance difference caused by positive or negative DC voltage, thereby improving the problem of flickers and residual images caused by the luminance difference. Therefore, image quality and reliability of the display is enhanced.

[0092] Second, the process of shielding the common electrodes and the data electrodes are carried out at the same time as the data line or gate line forming process so that the overall process can be simplified, thereby minimizing process time.

[0093] It will be apparent to those skilled in the art that various modifications and variation can be made in the present invention without departing from the spirit or scope of the invention. Thus, it is intended that the present invention cover the modifications and variations of this invention provided they come within the scope of the appended claims and their equivalents.

What is claimed is:

1. An in-plane switching liquid crystal display device, comprising:

first and second substrates;

a plurality of data lines on the first substrate;

a plurality of gate lines crossing the data lines on the first substrate, perpendicular to the data lines;

a plurality of pixel areas on said first substrate defined by the data and gate lines;

data electrodes and common electrodes alternately formed in each of said pixel areas, the data electrodes having a first transmittance area and the common electrodes having a second transmittance area, wherein the first transmittance area equals the second transmittance area; and

a liquid crystal layer between said first and second substrates.

2. The in-plane switching liquid crystal display device of claim 1, wherein the data electrodes and the common electrodes are on the same layer.

3. The in-plane switching liquid crystal display device of claim 1, wherein the data electrodes and the common electrodes are on different layers.

4. The in-plane switching liquid crystal display device of claim 1, further comprising at least one shielding layer on the first substrate under at least one of the common electrodes.

5. The in-plane switching liquid crystal display device of claim 4, wherein the shielding layer and the gate lines comprise a same material.

6. The in-plane switching liquid crystal display device of claim 4, wherein the shielding layer and the data lines comprise a same material.

7. The in-plane switching liquid crystal display device of claim 1, further comprising at least one shielding layer on the first substrate under at least one of the common electrodes and at least one additional shielding layer under at least one of the data electrodes such that light transmittance of the common electrodes is the same as light transmittance through the data electrodes

8. The in-plane switching liquid crystal display device of claim 7, wherein the shielding layer and the gate lines comprise a same material.

9. The in-plane switching liquid crystal display device of claim 7, wherein the shielding layer and the data lines comprise a same material.

10. The in-plane switching liquid crystal display device of claim 1, wherein a number of common electrodes having no shielding layer thereunder is equal to a number of data electrodes having no shielding layer thereunder.

11. The in-plane switching liquid crystal display device of claim 4, wherein the common electrode includes at least one outermost common electrode adjacent to at least one of said data lines; and

wherein the shielding layer is under the outermost common electrode.

12. The in-plane switching liquid crystal display device of claim 1, wherein at least one of the data electrodes has a first width, and at least one of the common electrodes has a second width, the second width being greater than the first width.

13. The in-plane switching liquid crystal display device of claim 12, wherein at least one of the data electrodes has a same width as at least one of the common electrodes.

14. The in-plane switching liquid crystal display device of claim 12, wherein the second width is 1.5 times the first width.

15. The in-plane switching liquid crystal display device of claim 12, wherein the second width is 2 times the first width.

16. The in-plane switching liquid crystal display device of claim 1, wherein at least one of the data electrodes has a first width, and at least one of the common electrodes has a second width, the first width being less than the second width.

17. The in-plane switching liquid crystal display device of claim 16, wherein the first width is one half the second width.

18. An in-plane switching liquid crystal display device, comprising:

first and second substrates;

a plurality of pixel areas on said first substrate;

data electrodes and common electrodes alternately formed in each of said pixel areas and patterned to have the same light transmitting area according to applied voltage; and

a liquid crystal layer between said first and second substrates.

19. The device of claim 18, further comprising a shielding layer under at least one of said plurality of data electrodes.

20. The device of claim 18, wherein said data electrodes and said common electrodes are formed on planes different from each other.

21. The device of claim 18, wherein said data electrodes and said common electrodes are formed on the same plane.

22. The device of claim 18, further comprising a shielding layer for shielding outermost ones of said common electrodes.

23. The device of claim 22, wherein said shielding layer is formed under said outermost ones of said common electrodes.

24. The device of claim 22, wherein said shielding layer is on said outermost ones of said common electrodes.

25. The device of claim 23, wherein said shielding layer formed on said common electrodes is integral with a black matrix on said second substrate.

26. The device of claim 18, wherein at least one of said common electrodes is wider than said data electrodes.

27. The device of claim 20, further comprising an insulation film on the data electrodes.

28. The device of claim 20, further comprising an insulation film on the common electrodes.

29. The device of claim 18, wherein said data electrodes and said common electrodes are a stripe type.

30. The device of claim 18, where in said data electrodes and said common electrodes are zigzag type.

31. The device of claim 18, further comprising gate lines and data lines defining said pixel areas; and switching devices at cross points of said gate and data lines.

32. A method of manufacturing an in-plane switching liquid crystal display device comprising:

preparing the first and second substrates;

forming a plurality of gate lines and data lines on the first substrate to define a plurality of pixel areas;

forming a plurality of data electrodes and common electrodes to be alternately formed in each pixel area and having the same light transmitting area; and

forming a liquid crystal layer between the first and second substrates.

33. The method of claim 32, wherein said step of forming a plurality of data electrodes and common electrodes includes:

forming an insulation film over a surface of the pixel area including the gate lines;

forming the data lines on the insulation film and forming a shielding layer having a predetermined width;

forming a first protective film on the surface including the shielding layer;

forming a plurality of data electrodes on the first protective film corresponding to areas between the shielding layer;

forming a second protective film on the surface including the data electrodes; and

forming common electrodes on the second protective film corresponding to areas between adjacent ones of the data electrodes.

34. The method of claim 32, wherein said step of forming a plurality of data electrodes and common electrodes includes:

forming an insulation film over a surface of the pixel area including the gate lines;

forming data lines on the insulation film and forming a shielding layer having a predetermined width;

forming a first protective film on the surface including the shielding layer;

forming a plurality of common electrodes on the first protective film;

forming a second protective film on the surface including the common electrodes; and

forming data electrodes on the second protective film corresponding to areas between adjacent ones of the common electrodes.

35. The method of claim 32, wherein said step of forming a plurality of data electrodes and common electrodes includes:

forming an insulation film over a surface of the pixel area including the gate lines;

forming data lines on the insulation film and forming a shielding layer having a predetermined width;

forming a first protective film on the surface including the shielding layer; and

alternately forming common electrodes and data electrodes on the first protective film.

36. The method of claim 33, wherein outermost ones of the plurality of common electrodes in the unit pixel are substantially vertically aligned with the shielding layer.

37. The method of claim 34, wherein outermost ones of the plurality of common electrodes in the unit pixel are substantially vertically aligned with the shielding layer.

38. The method of claim 33, further comprising the step of forming another shielding layer under at least one of the data electrodes.

39. The method of claim 34, further comprising the step of forming another shielding layer under at least one of the data electrodes.

40. The method of claim 33, wherein said shielding layer is formed of the same material as the data lines.

41. The method of claim 34, wherein said shielding layer is formed of the same material as the data lines.

42. The method of claim 38, wherein the shielding layer is formed of the same material as the data lines.

43. The method of claim 39, wherein the shielding layer is formed of the same material as the data lines.

44. The method of claim 32, wherein at least one of the plurality of common electrodes is formed wider than the data electrodes.

45. The method of claim 32, wherein the data electrodes and the common electrodes are formed of a transparent conductive material.

46. The method of claim 45, wherein the transparent conductive material is ITO.

摘要(译)

本发明涉及一种面内切换模式LCD及其制造方法，其中单位像素中的数据电极和公共电极具有相同的透光区域，以根据正极性或负极性减小亮度差异。施加直流电压。面内切换模式LCD包括第一和第二基板;多个像素区域限定在第一基板上;数据电极和公共电极交替地形成在每个像素区域中并被图案化以根据施加的电压具有相同的透光区域;以及第一和第二基板之间的液晶层。制造方法包括：制备第一和第二基板;在第一基板上形成多条栅极线和数据线以限定多个像素区域;形成多个数据电极和公共电极，在每个像素区域中交替形成，并且在施加电压时具有相同的透光区域;在第一和第二基板之间形成液晶层。
