A display device that can selectively display 2D and 3D images is provided. The display device includes a backlight unit, a liquid crystal device, and a light control device including two polarizing plates interposed between the backlight and the liquid crystal device each of the polarizing plates having a polarized pattern, and one of the polarizing plates being moveable. Therefore, the display device can selectively display 2D and 3D images by moving one of the polarizing plates parallel to the other polarizing plate, and a width of a light valve can be controlled by the degree of non-alignment of the polarizing plates.

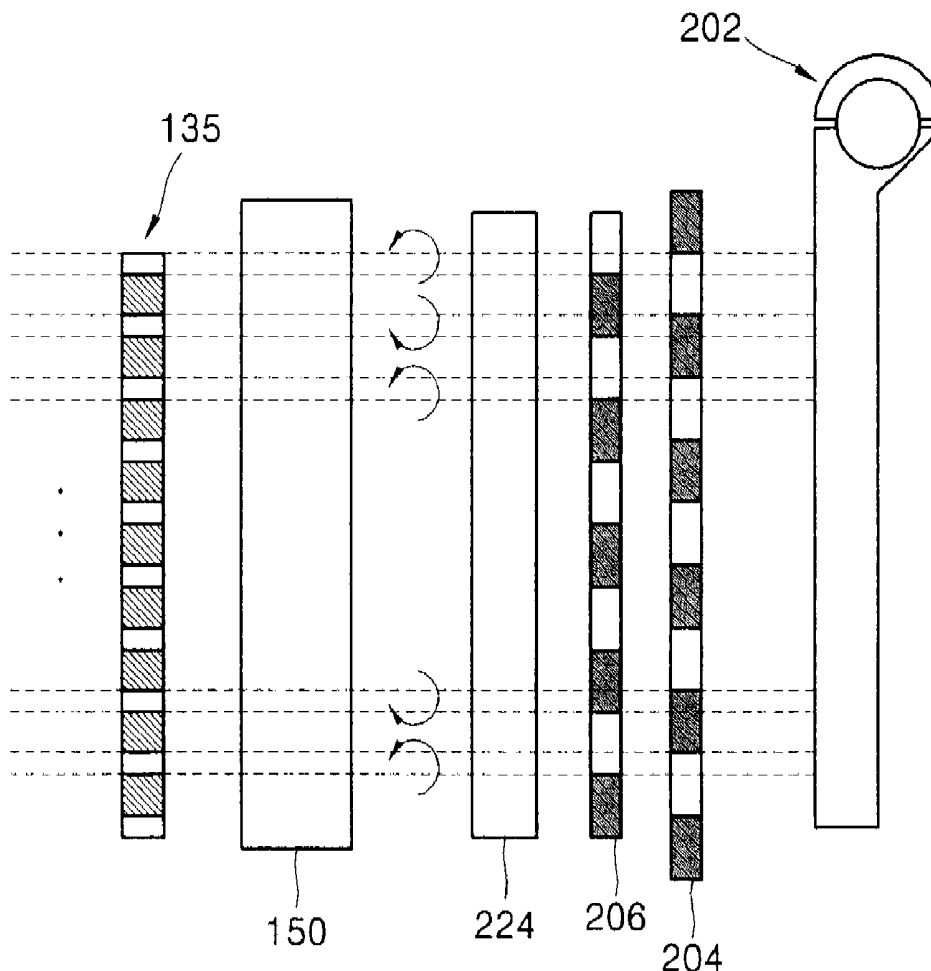


FIG. 1 (PRIOR ART)

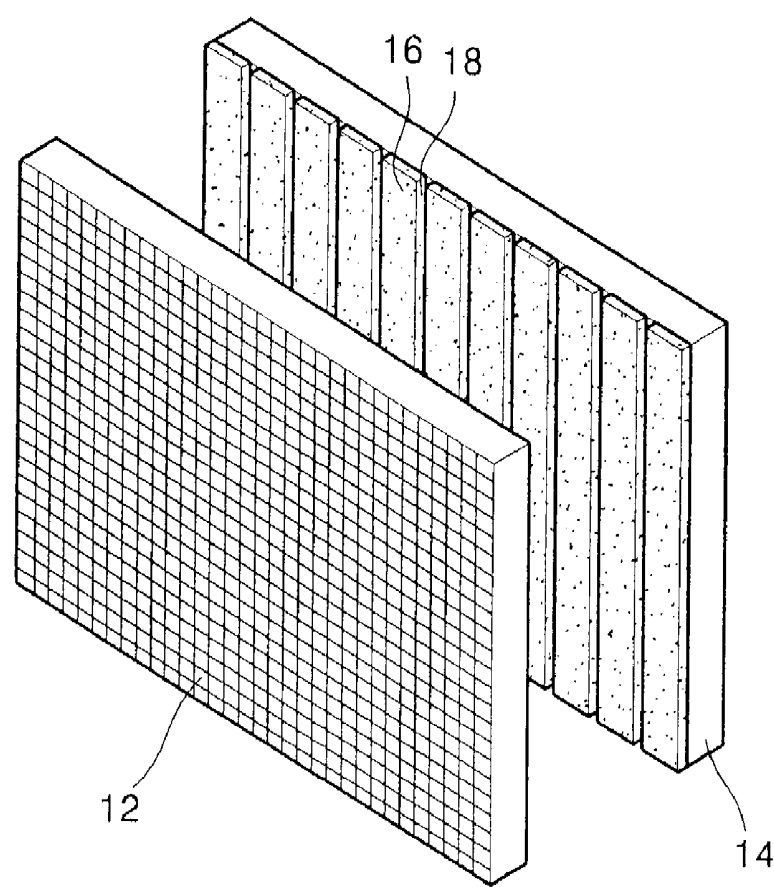


FIG. 2 (PRIOR ART)

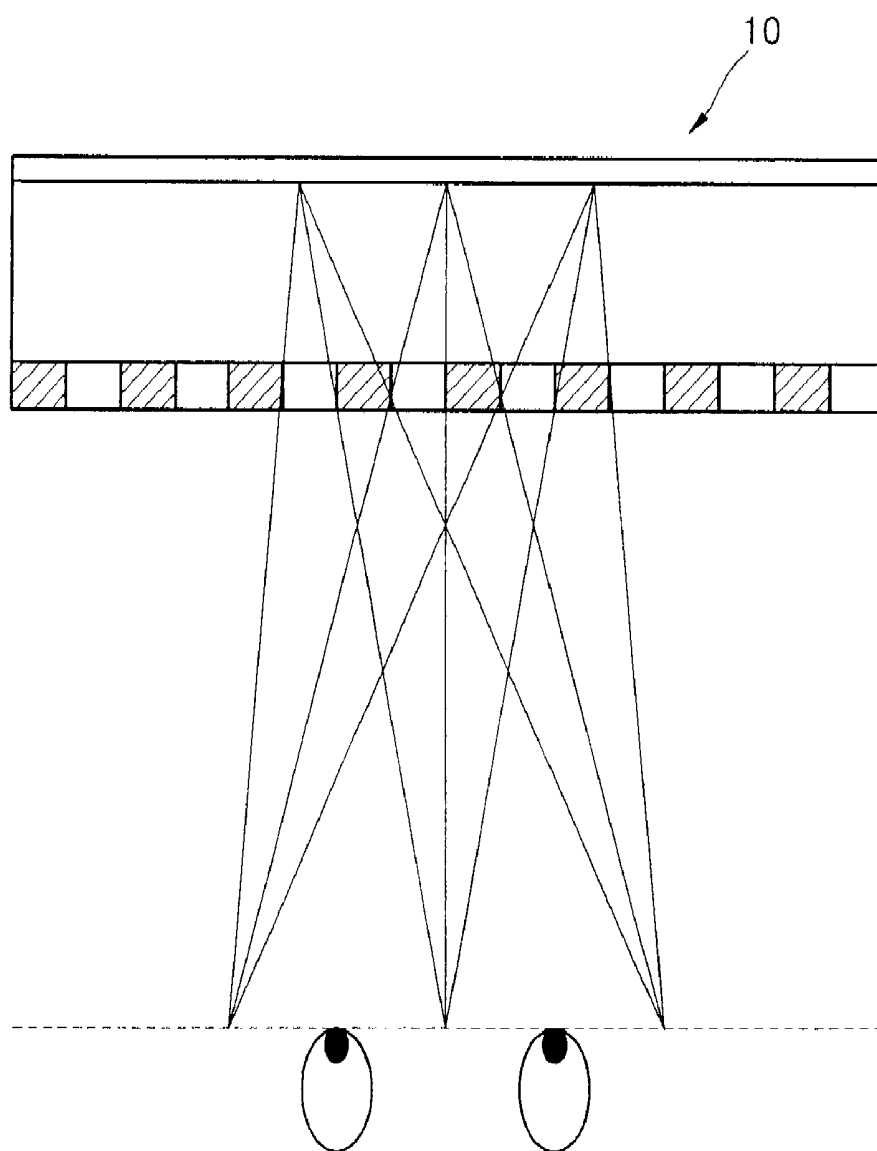

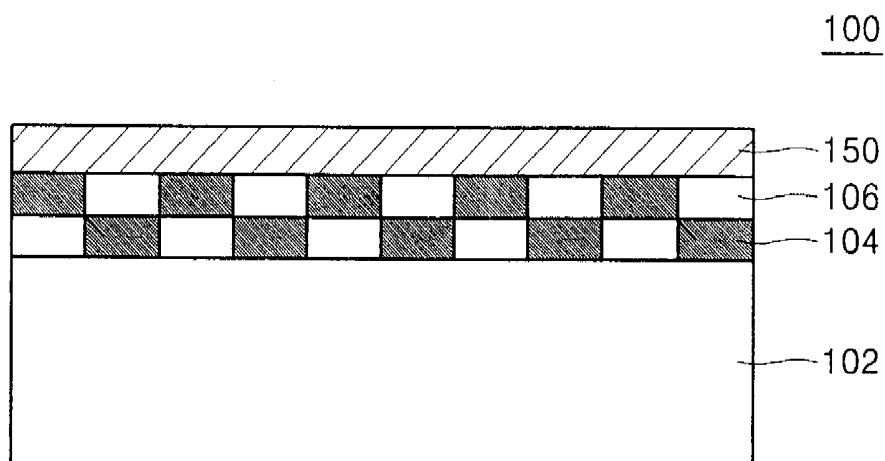

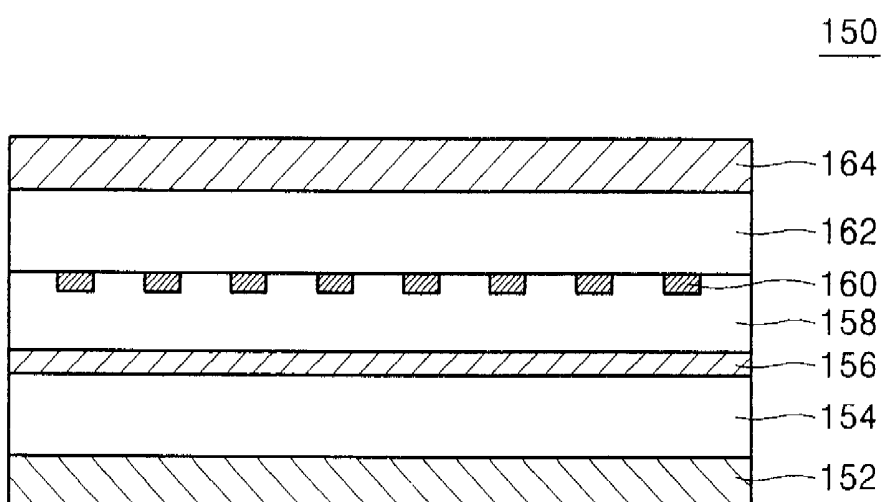

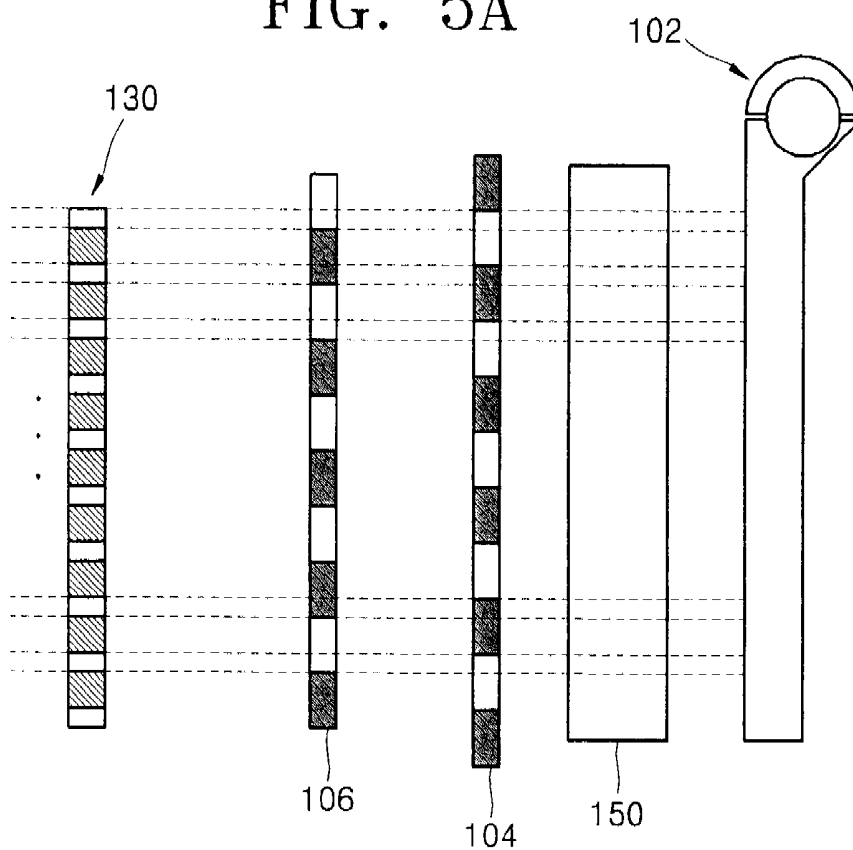

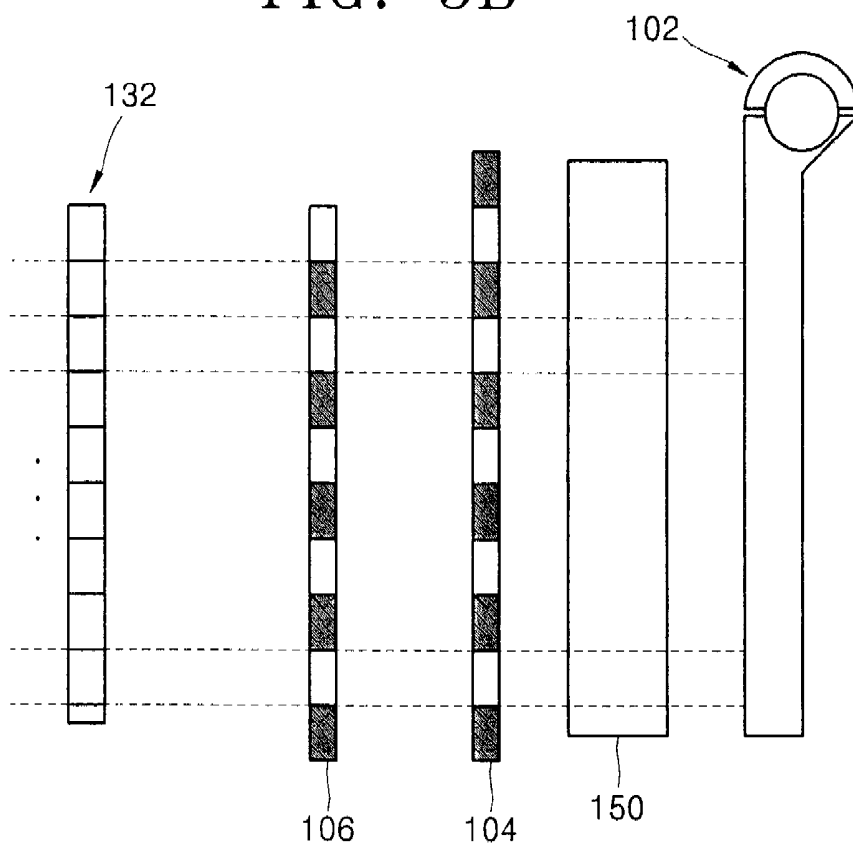

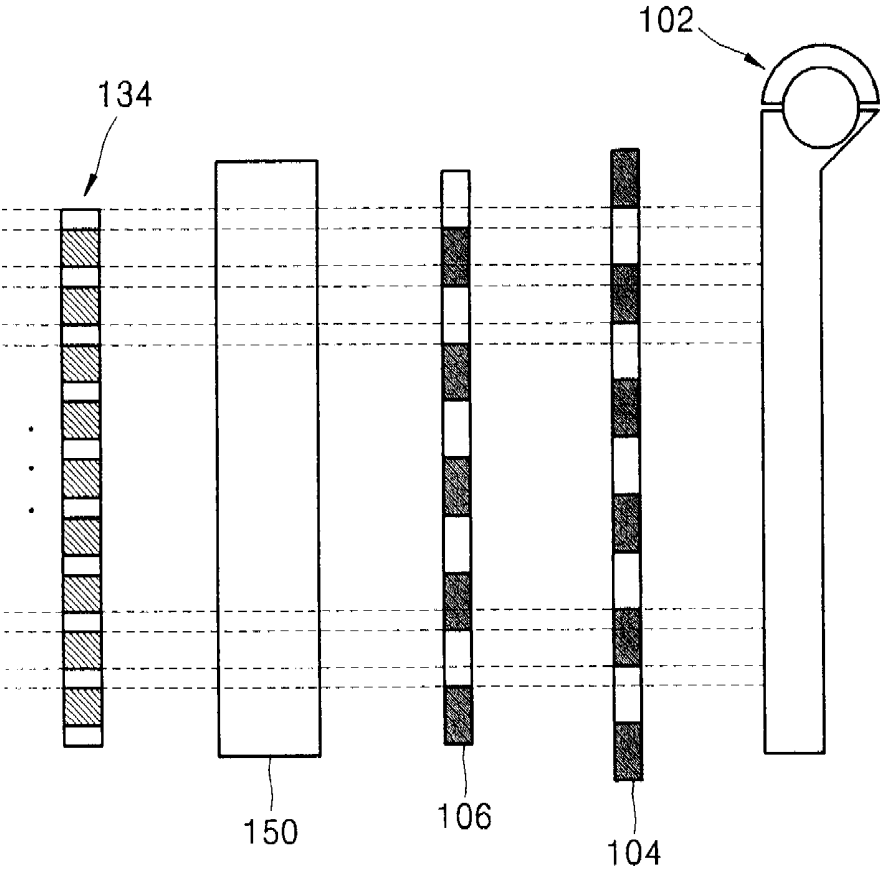

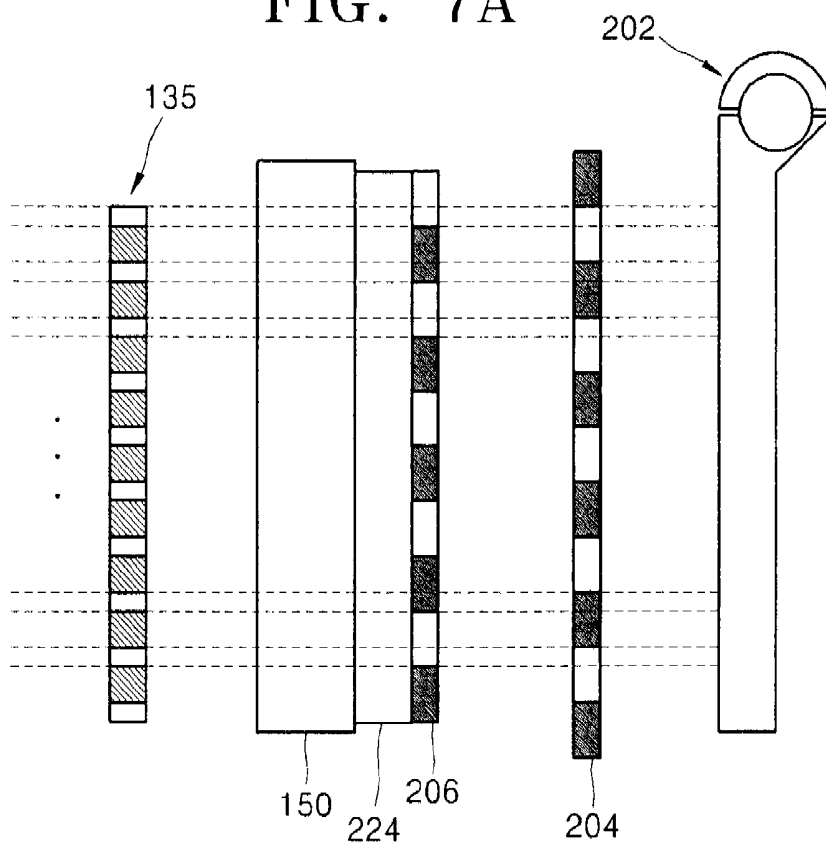

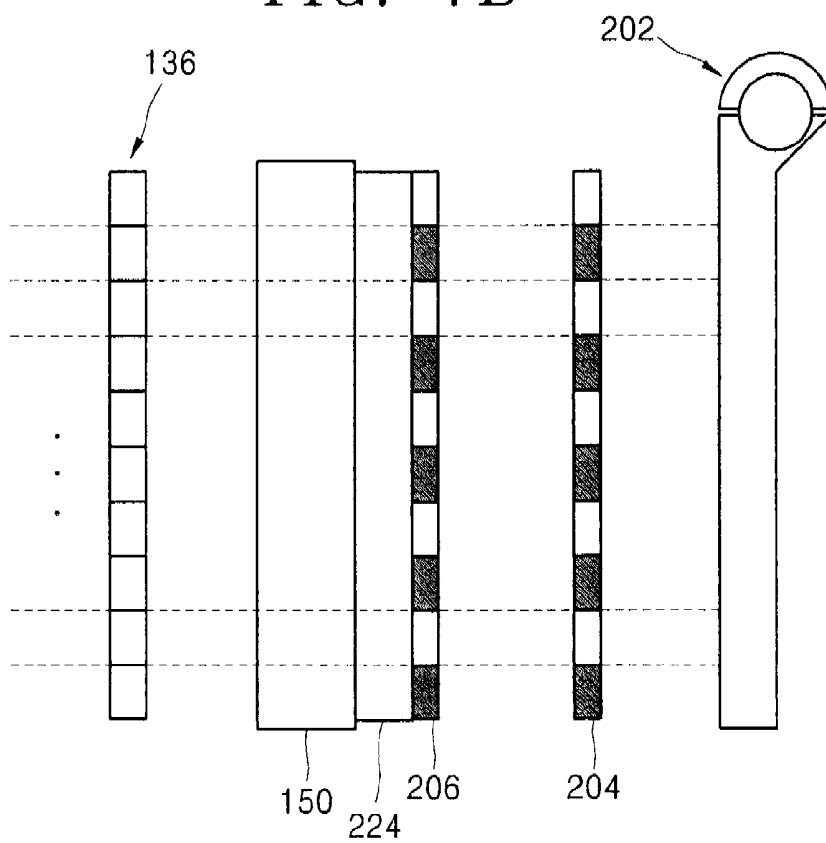
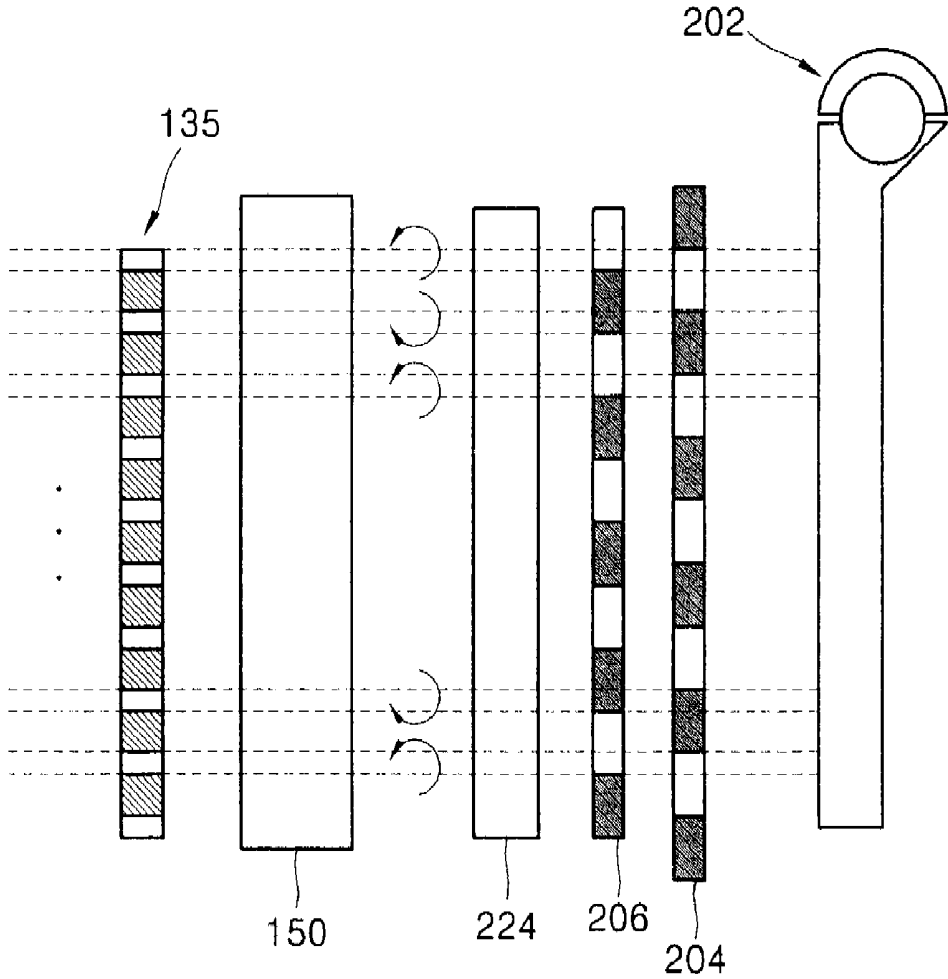

2D AND 3D DISPLAY DEVICE

BACKGROUND OF THE INVENTION

[0001] This application claims the priority of Korean Patent Application No. 2003-89356 filed on Dec. 10, 2003, in the Korean Intellectual Property Office, the disclosure of which is incorporated herein in its entirety by reference.

[0002] 1. Field of the Invention

[0003] The present invention relates to an electronic display device, and more particularly, to a display device that can selectively display two-dimensional (2D) and three-dimensional (3D) images.

[0004] 2. Description of the Related Art

[0005] Generally, to display a 3D image, binocular parallax is used. To display a 3D image using binocular parallax, either a stereoscopy method, wherein glasses are required, or an autostereoscopy method, wherein no glasses are required, have conventionally been used. Stereoscopy can require the use of polarized glasses or liquid crystal shutter glasses. Autostereoscopy, uses a lenticular display, a parallax barrier screen, or a parallax illumination.

[0006] Stereoscopy is mainly used when many people are viewing a 3D image, such as in a theatre using a polarized projector. Autostereoscopy, on the other hand, is mainly used when a small group of people are viewing an image, such as for personal use, display for a game, in a home TV set, in an exhibition display, etc.

[0007] The principle of 3D display using parallax illumination which is an autostereoscopy method, is disclosed in U.S. Pat. No. 4,717,949, entitled "Autostereoscopy Display with Illuminating Lines and Light Valve."

[0008] FIG. 1 is a perspective view of a display device according to the parallax illumination method disclosed in U.S. Pat. No. 4,717,949.

[0009] As depicted in FIG. 1, a display device implementing the parallax illumination method comprises a liquid crystal display 12 on which an image is displayed and an illumination plate 14, a front surface of which has a stationary barrier 16 having a plurality of slits 18 formed at a periodic interval in the back of the stationary barriers 16.

[0010] When light is emitted from a backlight mounted in the illumination plate 14, the illumination plate 14 becomes a backlight for the 3D image that irradiates light having stripe forms by passing through the plurality of slits 18 between the barriers 16. Pixels of odd-numbered columns of the LCD 12 display a left eye image observed by the left eye and the pixels of even-numbered columns display right eye image observed by right eye, thus obtaining a three dimensional image.

[0011] This method can only display three dimensional images. Therefore, since movies with 3D contents are relatively rare, consumers do get much use out of the device. Accordingly, there is a need to develop a display device capable of switching back and forth from 2D to 3D images as required.

[0012] FIG. 2 is a cross-sectional view of an autostereoscopic display disclosed in U.S. Pat. No. 6,157,424, which is a typical display unit that can display both 2D and 3D images.

[0013] The autostereoscopic display depicted in FIG. 2 has a structure that employs a liquid crystal shutter 10 which mounted behind a LCD 62, instead of stationary barriers 16. In this structure, the backlight can be used selectively as a 2D backlight that generally uniformly irradiates light and a 3D backlight that irradiates light of stripe from spaced apart with a predetermined distance by regionally controlling the permeability distribution of light generated from a backlight by a liquid crystal shutter 10 using an electrical signal.

[0014] The autostereoscopic display can easily alternate between 2D and 3D mode, however, a liquid crystal shutter 10 must be disposed behind the LCD 62. That is, two glass panels have to be used, thereby increasing the overall thickness of the LCD. Also, high power consumption is required to produce both 2D and 3D images.

SUMMARY OF THE INVENTION

[0015] The present invention provides a display device that employs a pair of patterned polarizers in a stationary parallax illumination device combined with a 2D display can switch between displaying 2D and 3D images by slightly moving the polarizers parallel to each other.

[0016] According to an aspect of the present invention, there is provided a display device that can switch between displaying 2D and 3D images, comprising: a backlight unit; a liquid crystal device; and a light control device that includes a pair of polarizing plates, disposed between the backlight and the liquid crystal device, wherein each polarizing plate of the pair of the polarizing plates have polarizing patterns, and at least one of the pair of the polarizing plates is moveable.

[0017] According to another embodiment of the present invention, there is provided a display device for displaying 2D images including a backlight unit and a liquid crystal device, in which a light control device that includes a pair of polarizing plates each having a polarizing pattern are disposed in front of the liquid crystal device, and a parallax illumination occurs by moving one of the pair of polarizing plates.

BRIEF DESCRIPTION OF THE DRAWINGS

[0018] The above and other features and advantages of the present invention will become more apparent by describing in detail exemplary embodiments thereof with reference to the attached drawings in which:

[0019] FIG. 1 is a perspective view of a conventional autostereoscopic display;

[0020] FIG. 2 is a cross-sectional view of a conventional autostereoscopic display that can display both 2D and 3D images;

[0021] FIG. 3 is a cross-sectional view of a display device consistent with a second exemplary embodiment of the present invention;

[0022] FIG. 4 is a cross-sectional view of one exemplary embodiment of a thin film transistor-liquid crystal device (TFT-LCD);

[0023] FIGS. 5A and 5B are cross-sectional views illustrating the operation of the display device consistent with a

first exemplary embodiment of the present invention wherein a pair of linear polarizing plates are disposed in front of the TFT-LCD;

[0024] FIG. 6 is a cross-sectional view illustrating the operation of a display device consistent with a second exemplary embodiment of the present invention wherein a pair of linear polarizing plates are disposed between a TFT-LCD and a backlight unit;

[0025] FIGS. 7A and 7B are cross-sectional views illustrating the operation of a display device consistent with a third embodiment of the present invention; and

[0026] FIG. 8 is a cross-sectional view for describing an operation of a display device according to the embodiment shown in FIG. 7A.

DETAILED DESCRIPTION OF EXEMPLARY NON-LIMITING EMBODIMENTS OF THE INVENTION

[0027] Exemplary embodiments of the present invention will now be described more fully with reference to the accompanying drawings. Like reference numerals refer to like elements throughout the drawings.

[0028] FIG. 3 is a cross-sectional view of a display device according to a first embodiment of the present invention.

[0029] Referring to FIG. 3, a LCD display device 100 comprises a backlight unit 102, a first polarizing plate 104, a second polarizing plate 106, and a thin film transistor liquid display device (TFT-LCD) 150. the LCD display device is not limited to using the TFT-LCD 150, but can include any transmissive display.

[0030] FIG. 4 is a cross-sectional view of the TFT-LCD 150 of FIG. 3.

[0031] Referring to FIG. 4, the TFT-LCD 150 comprises a first transparent substrate 154 having a third polarizing plate 152 disposed on a surface of the first transparent substrate 154, a transparent electrode 156 disposed on the other surface of the first transparent substrate 154, a liquid crystal unit 158 formed on the transparent electrode 156, a patterned transparent electrode 160 facing the transparent electrode 156 in the liquid crystal unit 158, a second transparent substrate 162 formed on the patterned transparent electrode 160, and a frontal polarizing plate 164 formed on the second transparent substrate 162.

[0032] The first and the second transparent substrate 154 and 162 may be formed of glass or polymer, and the transparent electrode 156 and the patterned transparent electrode 160 may both be formed of Indium-Tin-Oxide (ITO). However, those of skilled in the art would recognize that other materials may be used.

[0033] A maximum amount of light is transmitted through the two polarizing plates 104 and 106 when the two polarizing plates 104 and 106 are places parallel to each other, and no light is transmitted when the plates are placed perpendicular each other. The polarizing plates 104 and 106 can be formed by absorbing iodine or a bicolor dye on a patterned vertical alignment (PVA) film which is a polymer elongated to one direction. However, those of skill in the art would recognize that other material may be used.

[0034] FIGS. 5A and 5B are cross-sectional views illustrating the operation of the display when a pair of linear polarizing plates 104 and 106 are disposed in front of the TFT-LCD 150. In the drawings, the black colored regions of the pair of linear polarizing plates 104 and 106 represents 90° polarizing patterns, and the white region represents 0° polarizing patterns.

[0035] According to a first exemplary embodiment of the present invention, the frontal polarizing plate 164 of TFT-LCD 150 (see FIG. 4) is a 45° polarizing plate and the third polarizing plate 152 of TFT-LCD 150 is a 135° polarizing plate, and each of the first and the second polarizing plates 104 and 106 have an alternating 0° and 90° polarizing patterns.

[0036] Referring to FIG. 5A, light emitted from the backlight unit 102 reaches the first polarizing plate 104 after passing through the TFT-LCD 150. At this time, 45° polarized light exits from the TFT-LCD 150 since the light has to pass the front polarizing plate 164 having 45° polarization.

[0037] Then, the 45° polarized light passes through the 0° polarizing patterns and the 90° polarizing patterns of the first polarizing plate 104. Accordingly, the light passed through the first polarizing plate 104 has stripe form portions of 0° polarized light and stripe form portions of 90° polarized light, alternately disposed. Intensities of the 0° polarized light and the 90° polarized light are equal.

[0038] Next, the light having portions of the 0° polarized stripe form and the 90° polarized stripe form enters to the second polarizing plate 106. According to the present embodiment, it is preferred, but not necessary, that the second polarizing plate 106 has the same polarizing pattern as the first polarizing pattern 104. However, the size of the 0° and 90° polarizing patterns of the second polarizing plate 106 may be different from each other.

[0039] Phases of the polarizing patterns of the first polarizing plate 104 and those of the second polarizing plate 106 can be placed in a non-aligned manner by slightly moving one of the first polarizing plate 104 or the second polarizing plate 106 parallel to each other. This non-aligned state is shown in FIG. 5A.

[0040] In this case, the 0° polarized light exiting from the first polarizing plate 104 cannot pass through the 90° polarizing patterns but can pass through the 0° polarizing patterns of the second polarizing plate 106, and the 90° polarized light exiting from the first polarizing plate 104 cannot pass through the 0° polarizing patterns but can pass through the 90° polarizing patterns of the second polarizing plate 106. Thus, a light pattern 130 exits second polarizing plate 106.

[0041] From this effect, the pair of polarizing plates 104 and 106 act as a 3D barrier through which light having a line-shaped pattern passes so that a left eye and a right eye observe separate images. Thus, a 3D effect can be obtained by generating a left image for observation by a viewer's left eye in odd-numbered columns of the TFT-LCD 150 and generating a right image for observation by the viewer's right eye in even-numbered columns of the TFT-LCD 150.

[0042] Referring to FIG. 5B, the patterns of the first and the second polarizing plates 104 and 106 are aligned by slightly moving one of the first polarizing plate 104 and the second polarizing plate 106 parallel to the other such that the

light passing through the of 0° polarizing pattern of the first polarizing plate **104** can pass through the 0° polarizing patterns of the second polarizing plate **106**, and the light passing through the 90° polarizing patterns of the first polarizing plate **104** can pass through the 90° polarizing patterns of the second polarizing plate **106**.

[0043] Accordingly, the light passed through the pair of polarizing plates **104** and **106** can be observed as a 2D image in which the left eye and right eye see the same image, that is, this becomes an ordinary 2D image display device. Thus, a light pattern **132** exits second polarizing plate **106**.

[0044] FIG. 6 is a cross-sectional view for describing an operation of the display device **100** when the pair of linear polarizing plates **104** and **106** are disposed between the TFT-LCD **150** and the backlight unit **102**.

[0045] The display device in FIG. 6 has the same operational principle as the display device depicted in FIGS. 5A and 5B, with the only difference being that the pair of patterned polarizing plates **104** and **106** are disposed between the TFT-LCD **150** and the backlight unit **102**.

[0046] That is, in the case of the display device depicted in FIGS. 5A and 5B, the two patterned polarizing plates, i.e., the first and the second polarizing plates **104** and **106**, are disposed in front of the TFT-LCD **150** to act as a parallax barrier. However, in the case of the display device depicted in FIG. 6, the pair of patterned polarizing plates **104** and **106** are disposed between the backlight unit **102** and the TFT-LCD **150** to act as the 3D image display parallax barrier. Accordingly, the device depicted in FIG. 6 is a switching device that changes a type of a backlight between one used for viewing a 2D image and one used for viewing a 3D image by slightly moving the first polarizing plate **104**. The same effect can be obtained by slightly moving the second polarizing plate **106** parallel to the first polarizing plate **104**.

[0047] The principle of the display of FIG. 6 is the same principle as explained with reference to the FIGS. 5A and 5B. That is, light that has passed through the 0° polarizing patterns of each of the first polarizing plate **104** and the second polarizing plate **106**, and light that has passed through the 90° polarizing patterns of each of the first polarizing plate **104** and the second polarizing plate **106** can enter the TFT-LCD **150**, while light that has passed through the 0° polarizing patterns of the first polarizing plate **104** does not pass through the 90° polarizing patterns of the second polarizing plate **106**, and light that has passed through the 90° polarizing patterns of the first polarizing plate **104** cannot pass through the 0° polarizing patterns of the second polarizing plate **106**.

[0048] The light that has passed through the first and the second polarizing plates **104** and **106** enters the third polarizing plate **152** (see FIG. 4), which is polarized at 135° , disposed at the front of the TFT-LCD **150** with a uniform intensity. As described with reference to FIG. 5A, a 3D image can be observed by crossing the patterns of the two polarizing plates **104** and **106** by slightly moving the first and/or the second polarizing plates **104** and **106**.

[0049] On the other hand, 2D images can be observed by supplying a pattern for 2D images to the TFT-LCD **150** by aligning the two polarizing patterns of the first and second polarizing plates **104** and **106**.

[0050] Therefore, the display device **100** according to an embodiment of the present invention enables selectivity switching between 2D and 3D modes by slightly moving the first and the second polarizing plates **104** and **106** with respect to each other in parallel.

[0051] FIGS. 7A and 7B are cross-sectional views for describing an operation of a display device according to a third embodiment of the present invention. In the drawings, a black colored region of a pair of linear polarizing plates **204** and **206** represents a 135° polarizing pattern, and a white colored region represents 45° polarizing pattern.

[0052] The embodiment depicted in FIGS. 7A and 7B is different from the embodiment depicted in FIGS. 5A and 5B in that the pair of the first and the second polarizing plates **204** and **206** have stripe form patterns of 135° and 45° polarizing alternating patterns.

[0053] More specifically, when passing through the first polarizing plate **204** having the alternating 45° and 135° polarizing patterns, non-polarized light emitted from the backlight unit **202** becomes polarized light having 45° polarized and 135° polarized stripe form portions.

[0054] The 135° polarized light exiting from the first polarizing plate **204** cannot pass through the 45° polarizing patterns of the second polarizing plate **206** but can pass through the 135° polarizing patterns, and the 45° polarized light exiting from the first polarizing plate **204** cannot pass through the 135° polarizing patterns of the second polarizing plate **206**, but can pass through the 45° polarizing patterns of the second polarized plate **206**.

[0055] Thus, only light that has passed through the 45° polarizing patterns of both the first and second polarizing plates **204** and **206** or the 135° polarizing patterns of both the first and second polarizing plates **204** and **206** exit from the second polarizing plate **206**.

[0056] The light that passes through the second polarizing plate **206** enters a $\lambda/4$ plate **224**. A 135° polarized portion of light becomes left circularly polarized and a 45° polarized portion of the light becomes right circularly polarized when passing through the $\lambda/4$ plate **224**.

[0057] Accordingly, as depicted in FIG. 7A, the left circularly polarized light and the right circularly polarized light from a regularly spaced pattern **135** such that the left eye and the right eye see different images. This is done by slightly moving the first polarizing plate **204** in parallel with the second polarizing plate **206** and fixing the second polarizing plate **206** in place.

[0058] On the other hand, as depicted in FIG. 7B, to display a 2D image when the 45° polarizing patterns of the second polarizing plate **206** and the 45° polarizing patterns of the first polarizing plate **204** are aligned by moving the patterned first polarizing plate **204** in parallel with the second polarized plate **206**, thus aligning the 135° polarizing patterns of the second polarizing plate **206** and the 135° polarizing patterns of the first polarizing plate **204**. Then the light that passes through the 45° polarized regions of both the first and the second polarizing plates **204** and **206** is transformed into a left circularly polarized light by the $\lambda/4$ plate **224**, and the light that passes through the 135° polarizing patterns of both the first and the second polarizing plates **204** and **206** is transformed into right circularly

polarized light by the $\lambda/4$ plate **224**. At this time, the left circularly polarized light and the right circularly polarized light exiting from the $\lambda/4$ plate **224** are cast on a rear surface of the TFT-LCD **150**, and the intensity of light passing through the third polarizing plate **152**, which is 135° polarized, are uniform.

[0059] Accordingly, the light pattern **136** that has passed through the pair of non-polarizing plate **204** and **206** forms 2D images by allowing a left eye and a right eye to see identical images.

[0060] According to this embodiment, a width of a light valve through which light used for viewing 3D images passes can be easily controlled by moving one of the polarizing plates.

[0061] FIG. **8** is a cross-sectional view further illustrating the operation principle of a display device according to the embodiment shown in FIG. **7A**.

[0062] As described above, a display device according to the above described exemplary embodiments allows a viewer to switch between 2D and 3D images by slightly moving one of a pair of polarizing plates, each having polarized regions forming columns, and the width of light valve through which light passes when displaying a 3D image can be easily controlled.

[0063] Also, according to the above described embodiments of the present invention, a display device is capable of displaying both 2D and 3D images without requiring continuous power consumption when viewing 3D images since the device does not use a liquid crystal shutter.

[0064] While this invention has been particularly shown and described with reference to embodiments thereof, it will be understood by those skilled in the art that various changes in form and details may be made therein without departing from the spirit and scope of the invention as defined by the appended claims.

15. A display device comprising:

a backlight unit;

a liquid crystal device configured to display two-dimensional (2D) images and

a light control device disposed in front of the liquid crystal device, wherein the light control device includes a pair

of polarizing plates, each of the pair of polarizing plates having polarizing patterns, wherein one of the pair of the polarizing plate is moveable.

16. The display device of claim 15, wherein the polarizing pattern formed on each of the polarizing plates includes a plurality of alternating stripe form 0° polarizing patterns, and line-shaped 90° polarizing patterns.

17. The display device of claim 16, wherein one of the two polarizing plates disposed close to the backlight is moveable in parallel to the other polarizing plate.

18. The display device of claim 16, wherein the light control device displays three dimensional (3D) images when the 0° polarizing patterns of the moveable polarizing plate and the 0° polarizing patterns of the other polarizing plate are not aligned, and the 90° polarizing patterns of the moveable polarizing plate and the 90° polarizing patterns of the other polarizing plate are not aligned.

19. (canceled)

20. The display device of claim 18, wherein the light control device displays 2D images when the 0° polarizing patterns of the moveable polarizing plate and the 0° polarizing patterns of the other polarizing plate are aligned, and when the 90° polarizing patterns of the moveable polarizing patterns plate and the 90° polarizing patterns of the other polarizing plate are aligned.

21. The display device of claim 15, wherein the liquid crystal device comprises:

a first transparent substrate;

a third polarizing plate formed on a surface of the first transparent substrate;

a transparent electrode formed on the opposite surface of the first transparent substrate;

a liquid crystal unit formed on the transparent electrode;

a patterned transparent electrode formed in the liquid crystal unit;

a second transparent substrate formed on the liquid crystal unit; and

a frontal polarizing plate formed on the second transparent substrate.

22. The display device of claim 21, wherein the third polarizing plate is a 135° polarizing plate, and the frontal polarizing plate is a 45° polarizing plate.

摘要(译)

提供了一种可以选择性地显示2D和3D图像的显示设备。该显示装置包括背光单元，液晶装置和光控装置，该光控装置包括插入在背光和液晶装置之间的两个偏振板，每个偏振板具有偏振图案，并且一个偏振板是可移动的。因此，显示装置可以通过使一个偏振板平行于另一个偏振板来选择性地显示2D和3D图像，并且可以通过偏振板的不对准程度来控制光阀的宽度。
