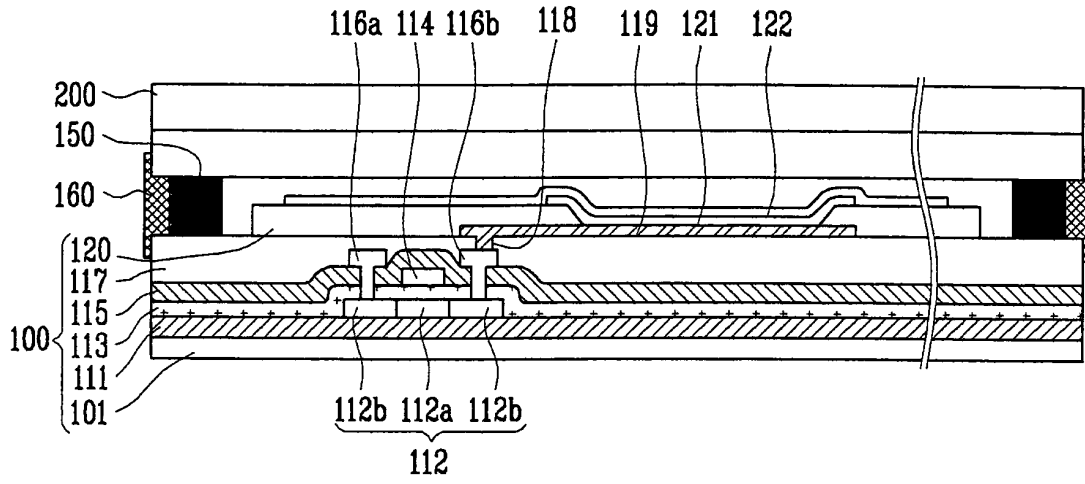
(54) **Organic light-emitting display device with frit seal and reinforcing structure**

(57) An organic light-emitting display device in which the substrate and the encapsulation substrate are attached to each other by using a frit. The organic light-emitting display device includes a first substrate including a pixel region in which an organic light-emitting diode is formed, and a non-pixel region. The organic light-emitting diode includes an organic light-emitting layer between a

first electrode and a second electrode. A second substrate attached to the first substrate. A frit is provided between the non-pixel region of the first substrate and the second substrate to attach the first substrate and the second substrate. A reinforcement material of resin is formed outside the frit.

摘要(译)

一种有机发光显示装置，其中基板和封装基板通过使用玻璃料彼此附接。有机发光显示装置包括第一基板和像素区域，第一基板包括其中形成有机发光二极管的像素区域。有机发光二极管包括在第一电极和第二电极之间的有机发光层。第二基板附着到第一基板。在第一基板的非像素区域和第二基板之间提供玻璃料，以附接第一基板和第二基板。在玻璃料外部形成树脂增强材料。
