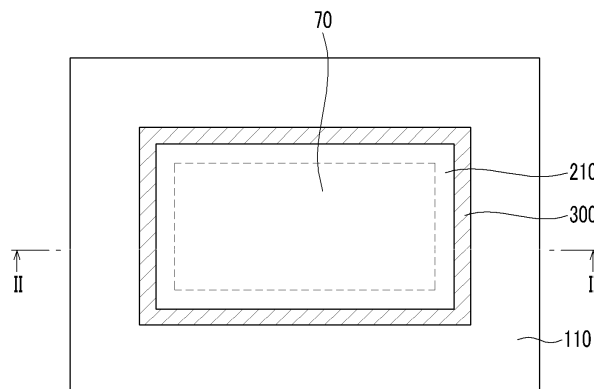

(54) **Organic light emitting diode display and method for manufacturing the same**

(57) An organic light emitting diode (OLED) display is disclosed. In one embodiment, the display includes i) a substrate (110), ii) a driving circuit (DC) formed on the substrate (110), iii) an organic light emitting diode (70) formed on the substrate (110) and electrically connected to the

driving circuit (DC), iv) an encapsulation thin film (210) formed on the driving circuit (DC) and organic light emitting diode (70) and v) a spacer (300) formed on the substrate (110) and surrounding the encapsulation thin film (210).

摘要(译)

公开了一种有机发光二极管 ( OLED ) 显示器。在一个实施例中，显示器包括i) 基板， ii) 形成在基板 ( 110 ) 上的驱动电路 ( DC )， iii) 形成在基板 ( 110 ) 上并且电连接到基板 ( 110 ) 的有机发光二极管 ( 70 )。驱动电路 ( DC )， iv) 形成在驱动电路 ( DC ) 和有机发光二极管 ( 70 ) 上的封装薄膜 ( 210 ) 和形成在基板 ( 110 ) 上并围绕封装的间隔物 ( 300 ) 薄膜 ( 210 )。
