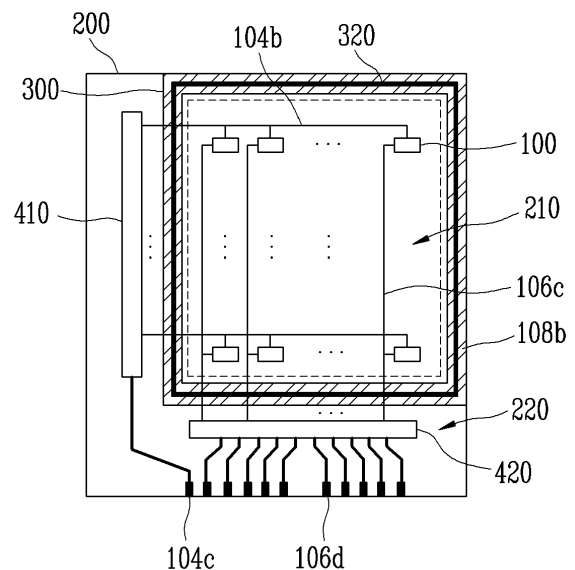

(54) **Organic electroluminescence display device**

(57) The invention relates to an organic electroluminescence display comprising:
a first substrate (200, 600) formed with organic electroluminescence elements (100, 500) each comprising a first electrode (108a, 509a), an organic thin film layer (110, 511) and a second electrode (111, 512) and metal wiring for transmitting signals to the organic electroluminescence elements (100, 500),
a second substrate (300, 700) arranged in a upper side of the first substrate (200, 600),
a frit (320, 720) provided between the first substrate (200, 600) and the second substrate (300, 700), and

- (i) a protective film (108b) formed of the same material as the first electrode (108a) and arranged between the metal wiring and the frit (320); or
- (ii) a first protective film (507) and a second protective film (509b) provided as a stacking structure between the metal wiring and the frit (720), wherein the second protective film (509b) is formed of the same material as the first electrode (509a).

摘要(译)

本发明涉及一种有机电致发光显示器，包括：由有机电致发光元件（100,500）形成的第一基板（200,600），每个有机电致发光元件包括第一电极（108a, 509a），有机薄膜层（110,511）和第二电极（111,512）和用于将信号传输到有机电致发光元件（100,500）的金属布线，布置在第一基板（200,600）的上侧的第二基板（300,700），玻璃料（320,720）设置在第一基板（200,600）和第二基板（300,700）之间，和（i）保护膜（108b），其由与第一电极（108a）相同的材料形成并且布置在金属配线和玻璃料（320）；或者（ii）第一保护膜（507）和第二保护膜（509b），其设置为金属布线和玻璃料（720）之间的堆叠结构，其中第二保护膜（509b）由与第一保护膜（509b）相同的材料形成。第一电极（509a）。
