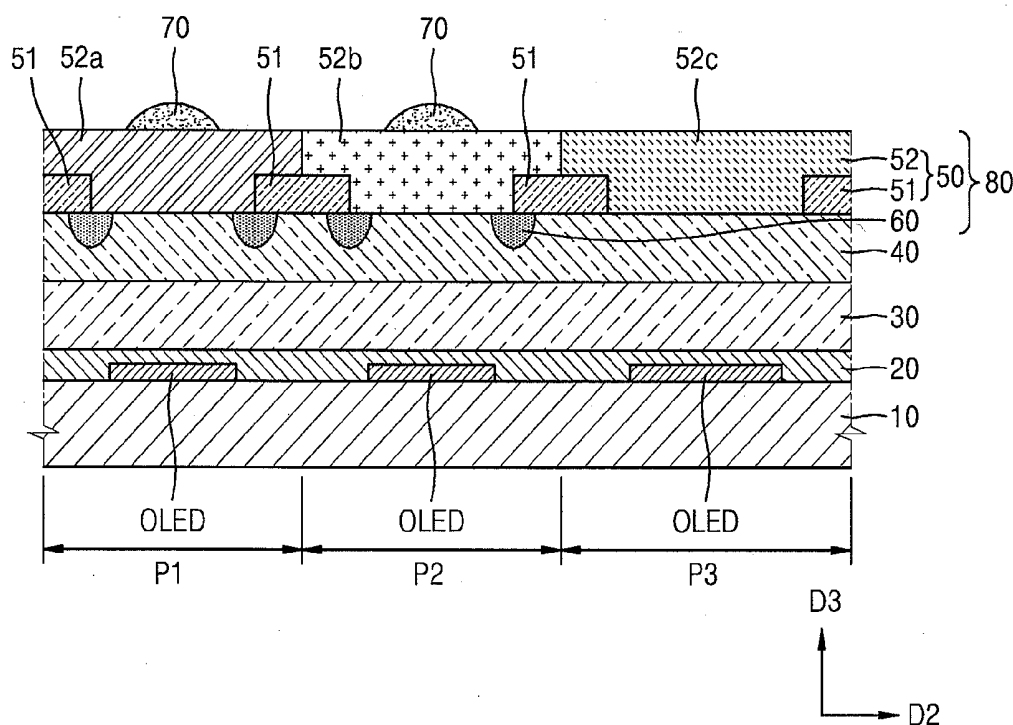

ABSTRACT

An organic light-emitting diode (OLED) display is disclosed. In one aspect, the display includes an OLED layer including a plurality of OLEDs that respectively form a plurality of sub-pixels and an encapsulation layer disposed over the OLED layer. The OLED display also includes an optical film disposed over the encapsulation layer and comprising a reflection control layer, a first lens disposed below the reflection control layer, and a second lens disposed over the reflection control layer, wherein the reflection control layer comprises i) a plurality of color filters respectively corresponding to the sub-pixels, and ii) a light shielding portion disposed between the color filters. The OLED display further includes an intermediate layer disposed between the encapsulation layer and the optical film, wherein the first lens is disposed over sides of at least one sub-pixels and wherein the second lens is disposed over center portions of selected sub-pixels.



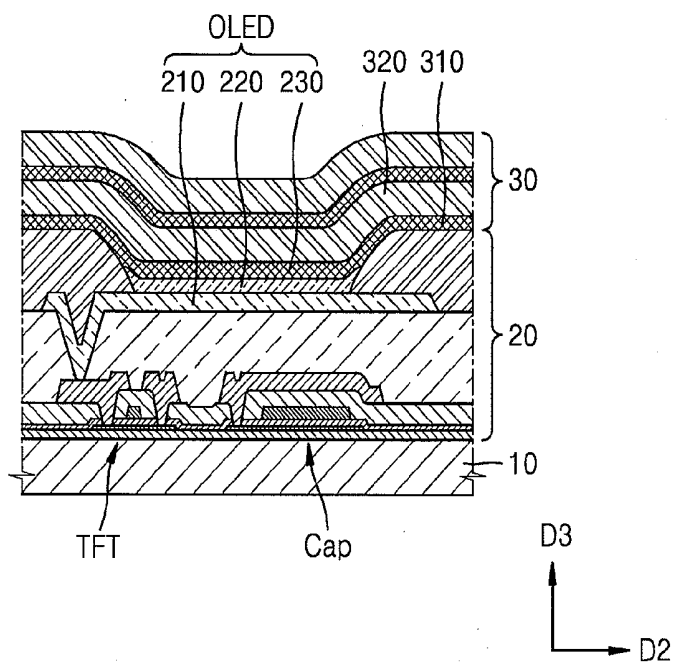

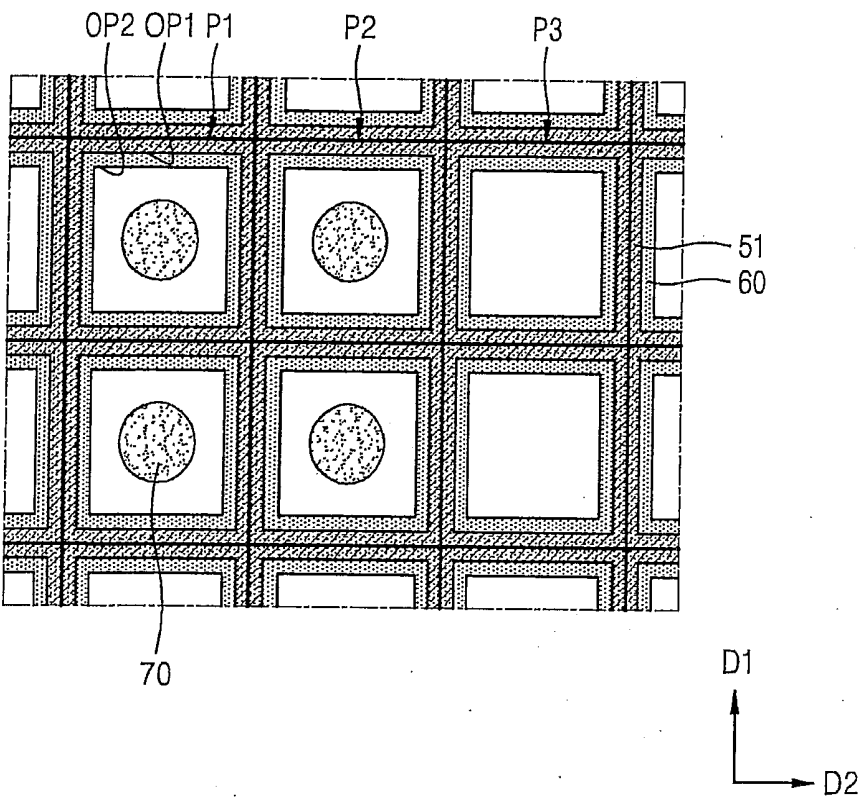

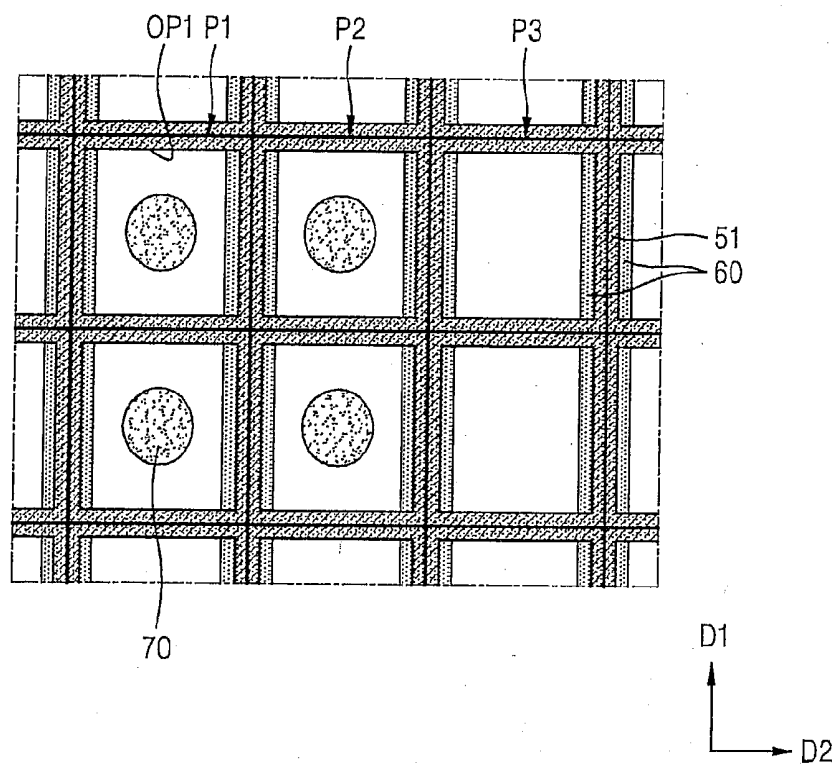
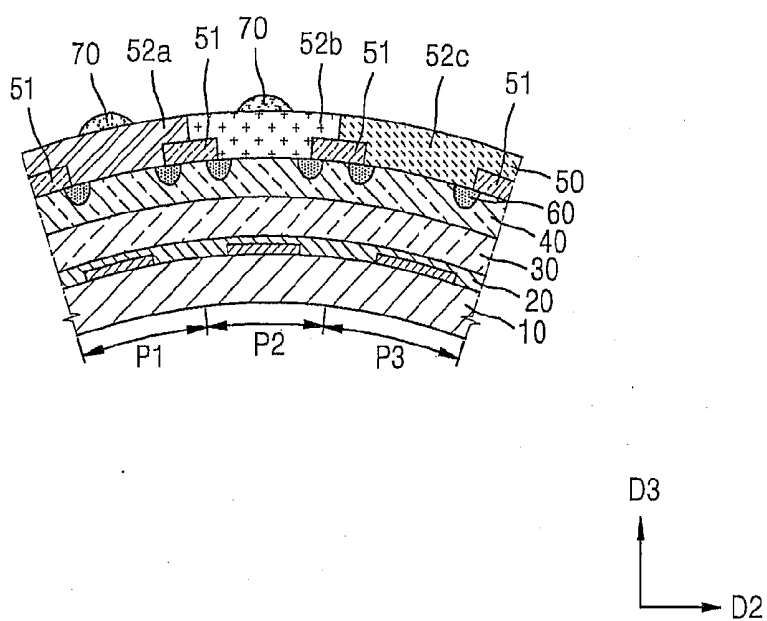
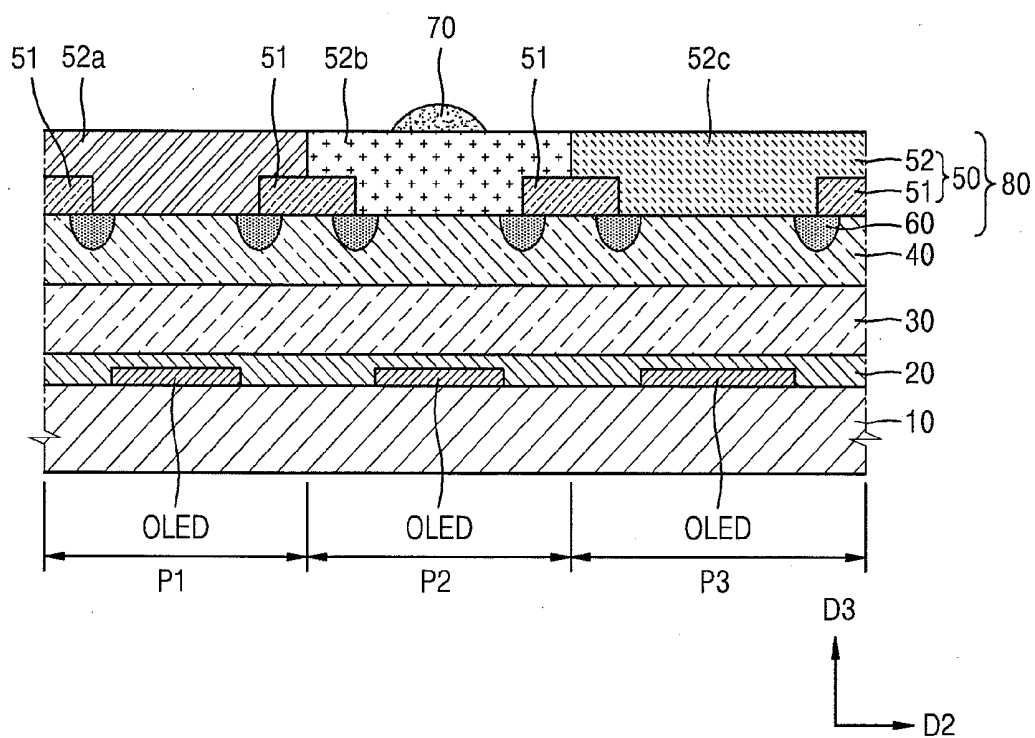
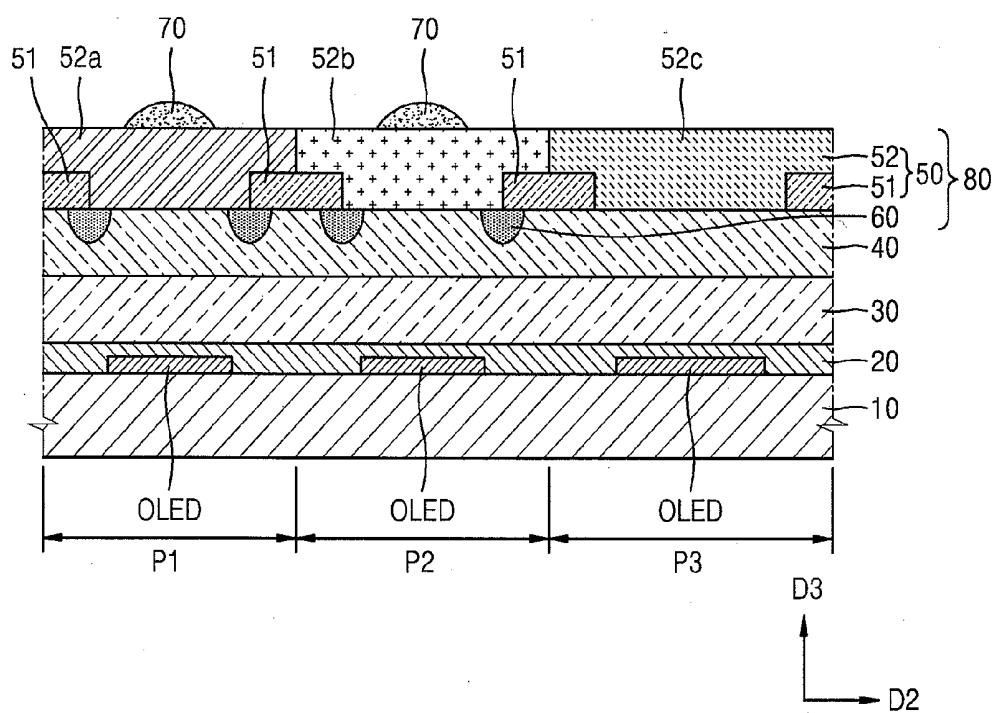

ORGANIC LIGHT-EMITTING DIODE (OLED) DISPLAY

CROSS-REFERENCE TO RELATED APPLICATIONS

[0001] This application claims the benefit, of Korean Patent Application No. 10-2014-0115691, filed on Sep. 1, 2014, in the Korean Intellectual Property Office, the disclosure of which is incorporated herein in its entirety by reference.

BACKGROUND

[0002] 1. Field

[0003] The described technology generally relates to an organic light-emitting diode (OLED) display.

[0004] 2. Description of the Related Technology

[0005] Recently, OLEDs have been highlighted for use as display devices that generate various types of images via selective light emission from a matrix of pixels.

[0006] An OLED display does not require a separate light source, unlike a liquid crystal display, and thus has a decreased thickness and weight. Also, OLED technology has high quality characteristics such as low power consumption, high brightness, and fast response time.

SUMMARY OF CERTAIN INVENTIVE ASPECTS

[0007] One inventive aspect is an OLED display.

[0008] Another aspect is an OLED display including a substrate; an organic light-emitting device layer formed on the substrate and including organic light-emitting devices that form a plurality of sub-pixels; an encapsulation layer on the organic light-emitting device layer; an optical film on the encapsulation layer and including a reflection control layer, a first lens formed below the reflection control layer, and a second lens formed on the reflection control layer, wherein the reflection control layer includes color filters respectively correspond to the plurality of sub-pixels, and a light shielding part that is formed between the color filters and includes a first opening; and an intermediate layer formed between the encapsulation layer and the optical film, wherein the first lens corresponds to sides of at least one sub-pixel among the plurality of sub-pixels, and the second lens corresponds to each of center portions of some sub-pixels among the plurality of sub-pixels.

[0009] The first lens may overlap a portion of the light shielding part.

[0010] A top surface of the intermediate layer may contact a bottom surface of the first lens.

[0011] The intermediate layer may have a low refractive index, and the first lens may have a high refractive index.

[0012] The plurality of sub-pixels may include a first sub-pixel, a second sub-pixel, and a third sub-pixel that respectively emit different lights, and the second lens may correspond to a center portion of at least one of the first sub-pixel and the second sub-pixel.

[0013] The second lens may not overlap the first lens.

[0014] The first opening may have a polygonal shape having at least four corners, and the first lens may be formed along at least two corners of the at least four corners of the first opening.

[0015] The first opening may have a quadrangular shape, and the first lens may be formed along two parallel corners from among corners of the first opening.

[0016] The first lens may have a convex surface protruding in an opposite direction of a travelling path of light emitted from the organic light-emitting device layer, and the second lens may have a convex surface protruding in a direction of the travelling path of the light.

[0017] A curvature of the convex surface of the second lens may be different from a curvature of the convex surface of the first lens.

[0018] An initial degree at an end of the first lens may be greater than about 40 degrees.

[0019] An initial degree at an end of the second lens may be greater than about 30 degrees.

[0020] Another aspect is an OLED display including an organic light-emitting device layer formed on a substrate and forming a first sub-pixel, a second sub-pixel, and a third sub-pixel; an encapsulation layer formed on the organic light-emitting device layer and including an organic layer and an inorganic layer that are alternately stacked; an optical film formed on the encapsulation layer and including a reflection control layer that includes a color filter formed on the first through third sub-pixels and a light shielding part located between the first through third sub-pixels and having a first opening, a first lens formed below the reflection control layer so as to be adjacent to the light shielding part, and a second lens formed on the reflection control layer; and an intermediate layer formed below the optical film so that a top surface thereof contacts a bottom surface of the first lens, wherein the first lens corresponds to at least one of the first through third sub-pixels, and the second lens corresponds to at least one of the first sub-pixel and the second sub-pixel.

[0021] The first lens may overlap a portion of the light shielding part.

[0022] The light shielding part may surround sides of each of the first through third sub-pixels, and the first lens may at least partially surround the sides of at least one of the first through third sub-pixels.

[0023] The second lens may correspond to a center portion of at least one of the first sub-pixel and the second sub-pixel.

[0024] The first opening may have a polygonal shape having at least four corners, and the first lens may be formed along at least two corners of the first opening.

[0025] The first lens may be formed along two parallel corners of the first opening.

[0026] The intermediate layer may have a low refractive index, and the first lens may have a high refractive index.

[0027] The second lens may have a convex surface protruding in a direction of a travelling path of light emitted from the organic light-emitting device layer, and the first lens may have a convex surface protruding in an opposite direction of the travel path of the light.

[0028] Another aspect is an organic light-emitting diode (OLED) display, comprising: a substrate; an OLED layer formed over the substrate and comprising a plurality of OLEDs that respectively form a plurality of sub-pixels; an encapsulation layer formed over the OLED layer; an optical film formed over the encapsulation layer and comprising a reflection control layer, a first lens formed below the reflection control layer, and a second lens formed over the reflection control layer, wherein the reflection control layer comprises i) a plurality of color filters respectively corresponding to the sub-pixels, and ii) a light shielding portion formed between the color filters and having a first opening; and an intermediate layer formed between the encapsulation layer and the optical film, wherein the first lens is formed over sides

of at least one of the sub-pixels, and wherein the second lens is formed over center portions of selected ones of the sub-pixels.

[0029] In the above display, the first lens overlaps and contacts a portion of the light shielding portion. In the above display, a top surface of the intermediate layer contacts a bottom surface of the first lens. In the above display, the intermediate layer has a first refractive index, and wherein the first lens has a second refractive index greater than the first refractive index. In the above display, the sub-pixels comprise a first sub-pixel, a second sub-pixel, and a third sub-pixel configured to respectively emit different colors of light, and wherein the second lens is formed over a center portion of at least one of the first and second sub-pixels. In the above display, the second lens does not overlap the first lens. In the above display, the first opening has a polygonal shape having at least four corners, and wherein the first lens is formed along at least two of the four corners of the first opening. In the above display, the first opening has a quadrangular shape, and wherein the first lens is foined along two parallel corners of the first opening.

[0030] In the above display, the first lens has a convex surface extending in an opposite direction of a travelling path of light emitted from the OLED layer, and wherein the second lens has a convex surface extending in a direction of the travelling path of the light. In the above display, the curvature of the convex surface of the second lens is different from the curvature of the convex surface of the first lens. In the above display, an initial degree at an end of the first lens is greater than about 40 degrees. In the above display, an initial degree at an end of the second lens is greater than about 30 degrees.

[0031] Another aspect is an organic light-emitting diode (OLED) display, comprising: an OLED layer formed over a substrate and forming a first sub-pixel, a second sub-pixel, and a third sub-pixel; an encapsulation layer formed over the OLED layer and comprising an organic layer and an inorganic layer that are alternately stacked; an optical film formed over the encapsulation layer and comprising i) a reflection control layer, wherein the reflection control layer comprises a color filter formed over each of the first through third sub-pixels and a light shielding portion located between the sub-pixels and having a first opening, ii) a first lens formed below the reflection control layer so as to be adjacent to the light shielding portion, and iii) a second lens formed over the reflection control layer; and an intermediate layer foamed below the optical film so that a top surface thereof contacts a bottom surface of the first lens, wherein the first lens is formed over at least one of the first through third sub-pixels, and wherein the second lens is formed over center portions of at least one of the first and second sub-pixels.

[0032] In the above display, the first lens overlaps and contacts a portion of the light shielding portion. In the above display, the light shielding portion surrounds sides of each of the first through third sub-pixels, and wherein the first lens at least partially surrounds the sides of at least one of the first through third sub-pixels. In the above display, the second lens does not overlap the first lens. In the above display, the first opening has a polygonal shape having at least four corners, and wherein the first lens is formed along at least two of the four corners of the first opening. In the above display, the first lens is formed along two parallel corners of the first opening. In the above display, the intermediate layer has a first refractive index, and wherein the first lens has a second refractive index greater than the first refractive index.

[0033] Another aspect is an organic light-emitting diode (OLED) display, comprising: a plurality of OLEDs respectively forming a plurality of sub-pixels; a plurality of color filters respectively formed over the sub-pixels; a plurality of sets of first lenses, each set formed between the corresponding OLED and the corresponding color filter, wherein each set of the first lenses contacts the corresponding color filter, wherein the number of the first lenses is greater than the number of the color filters; a plurality of second lenses formed over and contacting selected ones of the color filters, wherein the number of the color filters is greater than the number of the second lenses; and a plurality of light shielding layers each contacting two adjacent ones of the first lenses that contacting different color filters.

BRIEF DESCRIPTION OF THE DRAWINGS

[0034] FIG. 1 is a cross-sectional view of an OLED display according to an embodiment.

[0035] FIG. 2 is a cross-sectional view illustrating an encapsulation layer and an organic light-emitting device layer that corresponds to one of sub-pixels of the OLED display of FIG. 1.

[0036] FIG. 3 is a plan view illustrating a layout of sub-pixels, a light shielding part, a first lens, and a second lens of the OLED display, according to an embodiment.

[0037] FIG. 4A is a plan view illustrating a layout of sub-pixels, a light shielding part, a first lens, and a second lens of the OLED display, according to another embodiment.

[0038] FIG. 4B is a cross-sectional side view illustrating a bent state of the OLED display of FIG. 4A.

[0039] FIG. 5 is a cross-sectional view of an intermediate layer and an optical film that are formed on a sub-pixel of FIG. 1.

[0040] FIGS. 6A through 6C are cross-sectional views of an OLED display, according to another embodiment.

DETAILED DESCRIPTION OF CERTAIN INVENTIVE EMBODIMENTS

[0041] As the invention allows for various changes and numerous embodiments, particular embodiments will be illustrated in the drawings and described in detail in the written description. The effects and features of the present invention will now be described more fully with reference to the accompanying drawings, in which exemplary embodiments of the invention are shown. The invention may, however, be embodied in many different forms and should not be construed as being limited to the embodiments set forth herein.

[0042] Those components that are the same or are in correspondence are rendered the same reference numeral regardless of the figure number, and redundant explanations are omitted.

[0043] Throughout the specification, while such terms as “first,” “second,” etc., may be used to describe various components, such components must not be limited to the above terms. The above terms are used only to distinguish one component from another.

[0044] Throughout the specification, a singular form may include plural forms, unless there is a particular description contrary thereto.

[0045] Throughout the specification, terms such as “comprise” or “comprising” are used to specify existence of features and/or components described in the specification, not

excluding the existence of one or more other features and/or one or more other components.

[0046] It will be understood that when a layer, an area, a component, or the like is referred to as being “on” another layer, area, or component can be directly on another layer, area, or component or intervening layer, area, or component may also be present.

[0047] In the drawings, the thicknesses of layers and regions are exaggerated for clarity. For example, the thicknesses and sizes of elements in the drawings are arbitrarily shown for convenience of description, thus, the spirit and scope of the present invention are not necessarily defined by the drawings.

[0048] Also, it should also be noted that in some alternative implementations, the steps of all methods described herein may occur out of the order. For example, two steps illustrated in succession may in fact be executed substantially concurrently or the two steps may sometimes be executed in the reverse order. In this disclosure, the term “substantially” includes the meanings of completely, almost completely or to any significant degree under some applications and in accordance with those skilled in the art. Moreover, “formed on” can also mean “formed over.” The term “connected” includes an electrical connection.

[0049] FIG. 1 is a cross-sectional view of an OLED display according to an embodiment. FIG. 2 is a cross-sectional view illustrating an encapsulation layer 30 and an organic light-emitting device layer 20 that corresponds to one of sub-pixels of the OLED display of FIG. 1.

[0050] In the present embodiment, the OLED display includes a substrate 10, the organic light-emitting device layer 20, the encapsulation layer 30, an intermediate layer 40, and an optical film 80.

[0051] The substrate 10 may be formed of various materials including a glass material, a plastic material, or a plastic material including polyethylen terephthalate (PET), polyethylen naphthalate (PEN), or polyimide. If the substrate 10 is formed of the plastic material, the substrate 10 may have flexibility.

[0052] The organic light-emitting device layer 20 may be formed on the substrate 10 and may include a plurality of organic light-emitting devices OLEDs that emit lights of different colors. Each of the OLEDs may form a sub-pixel. For example, the OLED that emits red light may form a first sub-pixel P1, the OLED that emits green light may form a second sub-pixel P2, and the OLED that emits blue light may form a third sub-pixel P3.

[0053] Referring to FIG. 2, each of the OLEDs includes a pixel electrode 210, an emission layer 220, and an opposite electrode 230 and is electrically connected to a pixel circuit that includes a thin-film transistor TFT and a storage capacitor Cap so as to drive the corresponding organic light-emitting device OLED connected thereto.

[0054] The pixel electrode 210 may be a transparent (or translucent) electrode or a reflective electrode. If the pixel electrode 210 is a transparent (or translucent) electrode, the pixel electrode 210 may include at least one material selected from indium tin oxide (ITO), indium zinc oxide (IZO), zinc oxide (ZnO), indium oxide (In_2O_3), indium gallium oxide (IGO), and aluminum zinc oxide (AZO). If the pixel electrode 210 is a reflective electrode, the pixel electrode 210 may have a structure including a reflective layer that is formed of Ag, Mg, Al, Pt, Pd, Au, Ni, Nd, Ir, Cr, or a compound thereof and a layer that is formed of ITO, IZO, ZnO, or In_2O_3 on the

reflective layer. However, the structure and materials of the pixel electrode 210 are not limited thereto, and thus, the pixel electrode 210 may be formed of other materials or may be a multiple-layer.

[0055] The emission layer 220 may include an organic material that emits red light, green light, and blue light. The organic material that emits light may be a low molecular weight or a high molecular weight organic material. According to a type of the organic material, at least one selected from a hole transport layer, a hole injection layer, an electron transport layer, and an electron injection layer may be formed on the emission layer 220.

[0056] The opposite electrode 230 may be commonly formed to extend over a plurality of sub-pixels. The opposite electrode 230 may be transparent (or translucent) electrode or a reflective electrode. If the opposite electrode 230 is a transparent (or translucent) electrode, the opposite electrode 230 may have a structure including a layer that is formed of Li, Ca, LiF/Ca, LiF/Al, Al, Mg or compound of any of these and a transparent (or translucent) layer that is formed of ITO, IZO, ZnO or In_2O_3 on the layer. If the opposite electrode 230 is a reflective electrode, the opposite electrode 230 may include at least one material selected from Li, Ca, LiF/Ca, LiF/Al, Al, Ag and Mg. However, the structure and materials of the opposite electrode 230 are not limited thereto, and thus, the opposite electrode 230 may be formed of other materials or may be multiple layers.

[0057] The encapsulation layer 30 may be formed on the organic light-emitting device layer 20 and thus may protect the organic light-emitting device layer 20 from foreign substances and/or exterior air. In an embodiment, the encapsulation layer 30 may be formed of a glass material, so that the encapsulation layer 30 and the substrate 10 may be bonded to each other by using a sealant. In another embodiment, as illustrated in FIG. 2, the encapsulation layer 30 may be formed by alternately stacking an inorganic layer 310 and an organic layer 320.

[0058] Referring to FIG. 1, the optical film 80 is formed on travel paths of lights that are emitted from the sub-pixels. For example, the optical film 80 is formed above the encapsulation layer 30, and the intermediate layer 40 is formed under the optical film 80. The optical film 80 may include a reflection control layer 50, a first lens 60 formed below the reflection control layer 50, and a second lens 70 formed on the reflection control layer 50.

[0059] The reflection control layer 50 may include color filters 52 that respectively correspond to the sub-pixels, and light shielding parts 51 that are formed between adjacent sub-pixels (or between neighboring the color filters 52). For example, a red color filter 52a may be formed on the first sub-pixel P1 having the organic light-emitting devices OLED that emits red light, a green color filter 52b may be formed on the second sub-pixel P2 having the organic light-emitting devices OLED that emits green light, and a blue color filter 52c may be formed on the third sub-pixel P3 having the organic light-emitting devices OLED that emits blue light. As illustrated in FIGS. 1, 6A, and 6B, the light shielding parts 51 are formed between the color filters 52. For example, each light shielding part 51 may surround sides of each sub-pixel and thus may include a first opening OP1.

[0060] When external light is incident on the color filters 52, only a small portion of the incident external light is reflected, so that visibility of the external light and image resolution may be improved. The light shielding parts 51 may

be arranged to reduce contrast due to bottom reflection of the external light and may include a black matrix that absorbs light having a wavelength in a visible range. Bottom reflection means that the external light is reflected by electrodes of the organic light-emitting device OLED, a wire layer, or the substrate **10** those are formed below the reflection control layer **50**.

[0061] If a polarizing plate is used to decrease reflection of the external light, the manufacturing costs are increased, and since the thickness of the polarizing plate is relatively great, the OLED display including the polarizing plate is not bent. However, in the present embodiment, the reflection control layer **50** includes the color filters **52** and the light shielding parts **51**. Thus, the reflection control layer **50** may be formed to be relatively thin compared to the polarizing plate, be flexible, and require low manufacturing costs.

[0062] The first lens **60** may be formed below the reflection control layer **50**, and the second lens **70** may be formed on the reflection control layer **50**. The first lens **60** may correspond to at least one of the first sub-pixel **P1**, the second sub-pixel **P2**, and the third sub-pixel **P3**, and may be formed to be adjacent to the light shielding part **51** of each sub-pixel. For example, the first lenses **60** may correspond to the first sub-pixel **P1**, the second sub-pixel **P2**, and the third sub-pixel **P3**, respectively.

[0063] The second lens **70** may be selectively formed according to pixels. For example, the second lens **70** corresponds to one of the first sub-pixel **P1** and the second sub-pixel **P2**, and does not correspond to the third sub-pixel **P3**.

[0064] By doing so, the first lens **60** and the second lens **70** may compensate for a color impression of a side surface of the OLED display and may improve brightness of the side surface and overall luminescent efficiency of the OLED display. Hereinafter, with reference to FIGS. 3 through 5, the first lens **60** and the second lens **70** may be described in detail.

[0065] FIG. 3 is a plan view illustrating a layout of the first, second, and third sub-pixels **P1**, **P2**, and **P3**, the light shielding part **51**, the first lens **60**, and the second lens **70**, according to an embodiment of the present invention. FIG. 4A is a plan view illustrating a layout of the first, second, and third sub-pixels **P1**, **P2**, and **P3**, the light shielding part **51**, the first lens **60**, and the second lens **70**, according to another embodiment of the present invention. FIG. 4B is a cross-sectional side view illustrating a bent state of the OLED display of FIG. 4A. FIG. 5 is a cross-sectional view of the intermediate layer **40** and the optical film **80** that are formed on a sub-pixel of FIG. 1.

[0066] The first lens **60** may be formed to correspond to a side of at least one sub-pixel from among the first, second, and third sub-pixels **P1**, **P2**, and **P3**. The first lens **60** may be formed adjacent to the light shielding part **51** at a position that corresponds to a side of each sub-pixel. For example, as illustrated in FIG. 1, the first lens **60** may be formed to correspond to a side of each of the first, second, and third sub-pixels **P1**, **P2**, and **P3**.

[0067] The first lenses **60** may be formed at the sides of the first, second, and third sub-pixels **P1**, **P2**, and **P3** and may include areas **OL** that partly overlap with the light shielding parts **51**, respectively. Thus, the first lens **60** changes a travel path of light traveling toward the light shielding part **51** after being emitted from the OLED, thereby the light may be emitted outside.

[0068] The first lens **60** may have a convex surface protruding in an opposite direction of the travel path of the light (i.e., a **D3** direction) and may be formed of a material having a

relatively high refractive index. For example, the first lens **60** may be formed of a silicon-based material having a refractive index of between about 1.5 and about 1.9. On the other hand, the intermediate layer **40** that contacts the first lens **60** is formed of air (having a refractive index of 1) or an acryl-based material having a refractive index of between about 1 and about 1.4, thus, a portion of light that travels toward the light shielding part **51** after being emitted from the organic light-emitting device OLED may be refracted and thus may not be absorbed by the light shielding part **51** but may be emitted outside via the first opening **OP1**. In some embodiments, if the intermediate layer **40** is formed of a polymer material such as the acryl-based material having a refractive index of between about 1 and about 1.4, the intermediate layer **40** may function as a bonding layer.

[0069] Each of the first lenses **60** may be formed to correspond to sides of each of the sub-pixels and thus may at least partially surround the sides of each of the sub-pixels. In the present embodiment, as illustrated in FIG. 3, the first lens **60** may be formed while corresponding to the sides of each of the first, second, and third sub-pixels **P1**, **P2**, and **P3** and thus may substantially entirely surround the sides of each of the first, second, and third sub-pixels **P1**, **P2**, and **P3**. As described above, a portion of the first lens **60** overlaps a portion of the light shielding part **51** and other portion of the first lens **60** do not overlap the light shielding part **51** and thus is exposed via the first opening **OP1**, so that a second opening **OP2** that is formed due to the first lens **60** is smaller than the first opening **OP1**.

[0070] In another embodiment, when the first opening **OP1** has a polygonal shape having at least four corners, the first lens **60** may be formed along at least two corners from among the at least four corners of the first opening **OP1**. For example, as illustrated in FIG. 4A, the first lens **60** may be formed along two parallel corners of the first opening **OP1** having the polygonal shape. In this case, as illustrated in FIG. 4B, even when the OLED display is bent along a **D2** direction, the first lens **60** is not broken.

[0071] The second lens **70** has a convex surface protruding toward with respect to a travel path of light (i.e., the **D2** direction) that was emitted from the OLED, and diffuses the light that has passed through the reflection control layer **50**.

[0072] The second lens **70** may be formed to correspond to a center portion of at least one sub-pixel of the first sub-pixel **P1** and the second sub-pixel **P2**. For example, the second lens **70** is formed while corresponding to a center portion of each of the first sub-pixel **P1** that emits red light and the second sub-pixel **P2** that emits green light, and is not formed while corresponding to the third sub-pixel **P3** that emits blue light.

[0073] In a comparative example of the present embodiment, if the optical film **80** includes only the reflection control layer **50** that includes the color filter **52** and the light shielding part **51**, although light that is emitted from a blue color sub-pixel has an effect on an adjacent sub-pixel, the optical film **80** cannot control the effect. In this case, a bluish color may appear on a side surface of the OLED display.

[0074] However, in the present embodiment, the second lens **70** is formed while corresponding to the first and second sub-pixels **P1** and **P2** that emit red light and green light, respectively, so that the red light and green light further diffuse toward the side surface and thus the bluish color may be suppressed. Also, since the amount of light travels towards the side surface is increased due to the second lens **70**, brightness of the side surface may be improved.

[0075] As described above, the first lens 60 changes the travel path of the light travels toward the light shielding part 51, and the second lens 70 diffuses the light. Since functions of the first lens 60 and the second lens 70 are different from each other, the first lens 60 and the second lens 70 may have different curvatures. The second lens 70 may have a curvature smaller than a curvature of the first lens 60 so as to allow diffusions to occur in various directions.

[0076] For example, as illustrated in FIG. 5, a height h1 of the first lens 60 may be between about 1.0 and about 5.0 μm , and an initial degree θ_1 of the first lens 60 may be greater than about 40 degrees, and a height h2 of the second lens 70 may be greater than or equal to about 1.0 μm , and an initial degree θ_2 of the second lens 70 may be greater than about 30 degrees. Here, the initial degree may indicate an angle between a surface along D2 direction that is substantially vertical to the travel path (D3) of the light, and a surface S1 (or a surface S2) that contacts a normal vector passing an end point of a convex surface of a lens.

[0077] In order to allow a portion of light to travel without passing through the first lens 60, wherein the portion of the light is emitted from the OLED and travels straight in the D3 direction, a width of the first lens 60 may be smaller than a half of a width of the first opening OP1.

[0078] The first lens 60 and the second lens 70 may not overlap each other. If the second lens 70 has a large width that overlaps a width of the first lens 60, a large portion of light that is externally emitted passes through the second lens 70. That is, diffusion occurs a lot at the side surface, such that luminescent efficiency at a front surface may deteriorate. In order to prevent the deterioration, the first lens 60 and the second lens 70 may not overlap each other.

[0079] Table 1 below shows simulation results regarding the luminescent efficiency of an OLED display according to the comparative example and the luminescent efficiency of the OLED display according to the present embodiment.

[0080] The OLED display according to the comparative example includes the encapsulation layer 30 formed on the organic light-emitting device layer 20 having a bluish color at a side surface, the intermediate layer 40, and an optical film including the color filter 52 and the reflection control layer 50 having a light shielding layer. On the other hand, the OLED display according to present embodiment includes the encapsulation layer 30 formed on the organic light-emitting device layer 20 having a bluish color at a side surface, the intermediate layer 40, and the optical film 80 including a structure as shown in FIG. 1.

[0081] Referring to Table 1, when the overall luminescent efficiency of the OLED display according to the comparative example is 100%, although the front luminescent efficiency of the OLED display according to the present embodiment is 84.0%, the luminescent efficiency at a side surface of the OLED display according to the present embodiment is

improved, so that the overall luminescent efficiency of the OLED display according to the present embodiment is increased to 129.1%.

[0082] Since the second lens 70 was formed at each of positions that correspond to a red sub-pixel and a green sub-pixel, red light and green light diffused and thus the front luminescent efficiency was decreased by about 26.0%, however, brightness of the side surface has been improved due to the second lens 70, and a large portion of light is not absorbed by the light shielding part 51 and but is externally emitted due to the first lens 60, so that the overall luminescent efficiency has been improved by about 29.1%. Also, a bluish color that occurred in the case of the OLED display according to the comparative example at a viewing angle of 60 degrees of the side surface has been suppressed. In Table 1, a higher value in the row of the color coordinates at a viewing angle of a side surface indicates whiter light.

[0083] FIGS. 6A through 6C are cross-sectional views of an OLED display, according to another embodiment of the present invention.

[0084] As illustrated in FIGS. 6A through 6C, the second lens 70 may be formed so as to correspond to at least of a first sub-pixel P1 emitting red light and a second sub-pixel P2 emitting green light, and as illustrated in FIG. 6C, the first lens 60 may be formed only at the first sub-pixel P1 emitting red light and the second sub-pixel P2 emitting green light, not a third sub-pixel P3, in consideration of overall luminescent efficiency.

[0085] In the one or more embodiments mentioned above, the first sub-pixel P1 and the second sub-pixel P2 emit red light and green light, respectively, and the second lens 70 is formed to correspond to each of the first sub-pixel P1 and the second sub-pixel P2, so that a bluish color of a side surface of the OLED display is suppressed and brightness of the side surface is improved, but the described technology is not limited thereto.

[0086] According to a structure of a pixel circuit and a structure of the OLED that are included in the organic light-emitting device layer 20, the OLED display may express a bluish color, a reddish color, or a greenish color. However, according to the present embodiment, since the second lens 70 is selectively or differentially formed, a particular color impression of the side surface may be suppressed. In one embodiment, the first sub-pixel P1 and the second sub-pixel P2 emit green light and blue light, respectively, and the second lens 70 is formed so as to correspond to each of the first sub-pixel P1 and the second sub-pixel P2, so that a reddish color impression may be suppressed and brightness of the side surface may be increased. In another embodiment, the first sub-pixel P1 and the second sub-pixel P2 emit blue light and red light, respectively, and the second lens 70 is formed so as to correspond to each of the first sub-pixel P1 and the second sub-pixel P2, so that a greenish color impression may be suppressed and brightness of the side surface may be increased.

[0087] As described above, the OLED display according to at least one of the disclosed embodiments has improved luminescent characteristics.

[0088] It should be understood that the exemplary embodiments described therein should be considered in a descriptive sense only and not for purposes of limitation. Descriptions of features or aspects within each embodiment should typically be considered as available for other similar features or aspects in other embodiments.

[0089] While the inventive technology has been described with reference to the figures, it will be understood by those of ordinary skill in the art that various changes in form and details may be made therein without departing from the spirit and scope of the present invention as defined by the following claims.

What is claimed is:

1. An organic light-emitting diode (OLED) display, comprising:

a substrate;

an OLED layer disposed over the substrate and comprising a plurality of OLEDs that respectively form a plurality of sub-pixels;

an encapsulation layer disposed over the OLED layer;

an optical film disposed over the encapsulation layer and comprising a reflection control layer, a first lens disposed below the reflection control layer, and a second lens disposed over the reflection control layer, wherein the reflection control layer comprises i) a plurality of color filters respectively corresponding to the sub-pixels, and ii) a light shielding portion disposed between the color filters and having a first opening; and

an intermediate layer disposed between the encapsulation layer and the optical film,

wherein the first lens is disposed over sides of at least one of the sub-pixels, and wherein the second lens is disposed over center portions of selected ones of the sub-pixels.

2. The OLED display of claim 1, wherein the first lens overlaps a portion of the light shielding portion.

3. The OLED display of claim 1, wherein a top surface of the intermediate layer contacts a bottom surface of the first lens.

4. The OLED display of claim 3, wherein the intermediate layer has a first refractive index, and wherein the first lens has a second refractive index greater than the first refractive index.

5. The OLED display of claim 1, wherein the sub-pixels comprise a first sub-pixel, a second sub-pixel, and a third sub-pixel configured to respectively emit different colors of light, and wherein the second lens is disposed over a center portion of at least one of the first and second sub-pixels.

6. The OLED display of claim 1, wherein the second lens does not overlap the first lens.

7. The OLED display of claim 1, wherein the first opening has a polygonal shape having at least four corners, and wherein the first lens is disposed along at least two of the four corners of the first opening.

8. The OLED display of claim 1, wherein the first opening has a quadrangular shape, and wherein the first lens is disposed along two parallel corners of the first opening.

9. The OLED display of claim 1, wherein the first lens has a convex surface extending in an opposite direction of a travelling path of light emitted from the OLED layer, and wherein the second lens has a convex surface extending in a direction of the travelling path of the light.

10. The OLED display of claim 9, wherein the curvature of the convex surface of the second lens is different from the curvature of the convex surface of the first lens.

11. The OLED display of claim 1, wherein an initial degree at an end of the first lens is greater than about 40 degrees.

12. The OLED display of claim 1, wherein an initial degree at an end of the second lens is greater than about 30 degrees.

13. An organic light-emitting diode (OLED) display, comprising:

an OLED layer disposed over a substrate and forming a first sub-pixel, a second sub-pixel, and a third sub-pixel; an encapsulation layer disposed over the OLED layer and comprising an organic layer and an inorganic layer that are alternately stacked;

an optical film disposed over the encapsulation layer and comprising i) a reflection control layer, wherein the reflection control layer comprises a color filter disposed over each of the first through third sub-pixels and a light shielding portion located between the sub-pixels and having a first opening, ii) a first lens disposed below the reflection control layer so as to be adjacent to the light shielding portion, and iii) a second lens disposed over the reflection control layer; and

an intermediate layer disposed below the optical film so that a top surface thereof contacts a bottom surface of the first lens,

wherein the first lens is disposed over at least one of the first through third sub-pixels, and wherein the second lens is disposed over center portions of at least one of the first and second sub-pixels.

14. The OLED display of claim 13, wherein the first lens overlaps and contacts a portion of the light shielding portion.

15. The OLED display of claim 13, wherein the light shielding portion surrounds sides of each of the first through third sub-pixels, and wherein the first lens at least partially surrounds the sides of at least one of the first through third sub-pixels.

16. The OLED display of claim 13, wherein the second lens does not overlap the first lens.

17. The OLED display of claim 13, wherein the first opening has a polygonal shape having at least four corners, and wherein the first lens is disposed along at least two of the four corners of the first opening.

18. The OLED display of claim 13, wherein the first lens is disposed along two parallel corners of the first opening.

19. The OLED display of claim 13, wherein the intermediate layer has a first refractive index, and wherein the first lens has a second refractive index greater than the first refractive index.

20. An organic light-emitting diode (OLED) display, comprising:

a plurality of OLEDs respectively forming a plurality of sub-pixels;

a plurality of color filters respectively disposed over the sub-pixels;

a plurality of sets of first lenses, each set disposed between the corresponding OLED and the corresponding color filter, wherein each set of the first lenses contacts the corresponding color filter, wherein the number of the first lenses is greater than the number of the color filters;

a plurality of second lenses disposed over and contacting selected ones of the color filters, wherein the number of the color filters is greater than the number of the second lenses; and

a plurality of light shielding layers each contacting two adjacent ones of the first lenses that contacting different color filters.

摘要(译)

公开了一种有机发光二极管 (OLED) 显示器。在一个方面，显示器包括 OLED 层，OLED 层包括分别形成多个子像素的多个 OLED 和设置在 OLED 层上方的封装层。OLED 显示器还包括设置在封装层上方并包括反射控制层的光学膜，设置在反射控制层下方的第一透镜，以及设置在反射控制层上方的第二透镜，其中反射控制层包括 i) a 分别对应于子像素的多个滤色器，以及 ii) 设置在滤色器之间的遮光部分。OLED 显示器还包括设置在封装层和光学膜之间的中间层，其中第一透镜设置在至少一个子像素的侧面上，并且其中第二透镜设置在所选择的子像素的中心部分上。
