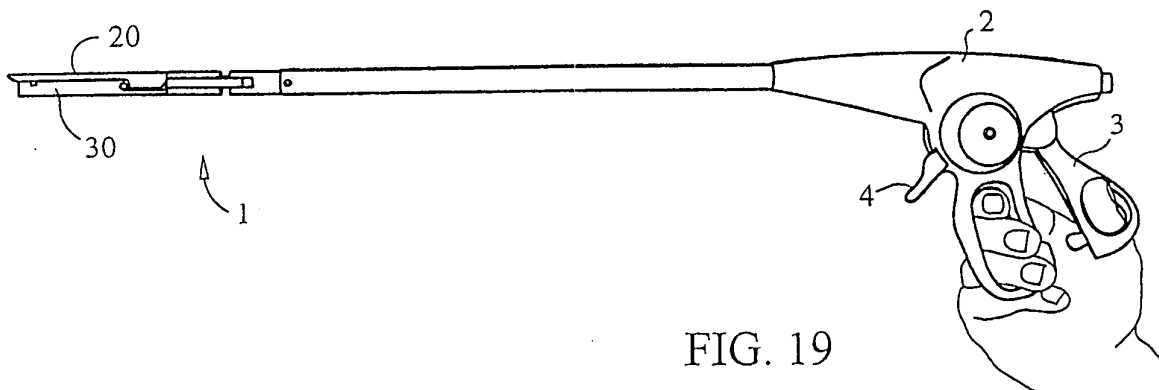

(54) **Medical device**

(57) A medical device comprises a pistol-shaped handle (2-4), a surgical end effector (1, 20, 30) connected to a distal end of a shaft extending from the handle (2-4), a surgical procedure actuator (3) for carrying out a surgical procedure on tissue at the surgical end effector (1,

20, 30), and a rotating knob at the handle (2-4). The rotating knob is rotatable with respect to the shaft about a shaft axis and is operable to operate the surgical procedure actuator and effect the surgical procedure.

摘要(译)

医疗装置包括手枪形手柄 (2-4) , 连接到从手柄 (2-4) 延伸的轴的远端的外科端部执行器 (1,20,30) , 外科手术致动器 (3) 用于在外科端部执行器 (1,20,30) 处的组织上执行外科手术, 以及在手柄 (2-4) 处的旋钮。旋转旋钮可相对于轴绕轴的轴线旋转, 并且可操作以操作外科手术致动器并实现外科手术。
