摘要(译)

描述了用于保护血栓形成疾病的药物，其包含诱导凝血细胞上的胶原受体的不可逆失活或降解的活性成分。抗体，特别是人源化单克隆抗体JAQ1是优选的活性成分。此外，公开了用于测定胶原受体GPVI的表达速率的诊断剂，其包含针对GPVI表位的标记的单克隆或多克隆抗体，优选如JAQ1所定义的。
