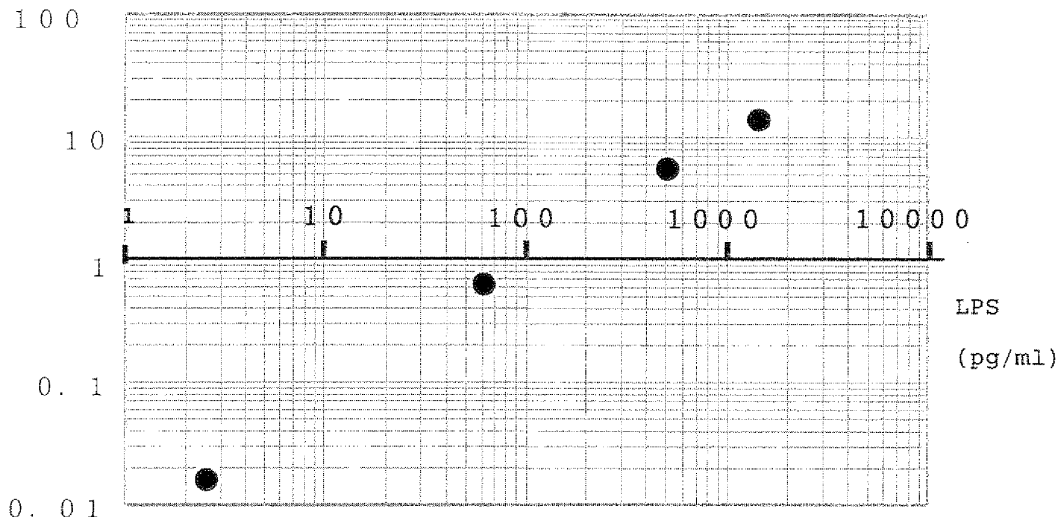
(54) **Adiponectin as endotoxin-neutralising agent**
